Monitoring for provision judged as inadequate

An Ofsted inspector, Maria Conroy, monitored your provision on 07/05/2015 following your inspection where the provision was judged to be inadequate.

Outcome of monitoring

As a result of our inspection on 02/03/2015, we sent you a welfare requirements notice. If you were set actions at the inspection, or as a result of our subsequent monitoring or investigations, these are included at the end of this letter.

The steps you were required to take were detailed in full in the notices sent to you on 26 March 2015. A previous monitoring visit, completed on 14 April 2015 found that you had taken steps to address the welfare requirement notice.

During the monitoring visit of 7 May 2015, the inspector discussed with you the steps you have taken to address the notices to improve. We found that you had developed your knowledge and understanding of safeguarding procedures and have a written policy in place, including the use of mobile phones and cameras. The procedure also includes contact details for the relevant authorities. You have engaged with the local authority service improvement officer. This has enabled you to become more familiar with the learning and development requirements and the cycle for assessment and planning. You are more aware of what is required in relation to the progress check at two years, who you should share the information with and the purpose of the check. You reviewed the information gained from parents about their child and now obtain more detail through the 'all about me' format. This will enable you to be better informed about each child in your care. Information shared with parents about activities, is mainly verbal. However you will share written procedures and you are in the process of gathering information in relation to the Early Years Foundation Stage curriculum. Finally you have reviewed the hygiene procedures for children to dry their hands in the bathroom, which will help to prevent cross infection.

Having considered all the evidence, the inspector is of the opinion that the childminder has taken prompt and effective action to address the points for improvement.
