Summary of key findings for parents

The provision meets requirements

- The childminder has addressed the actions and recommendations from her last inspection. She has updated her knowledge of safeguarding through training and demonstrated a clear understanding of child protection issues. She is aware of her responsibility to promote children's health and well-being, and holds a current paediatric first-aid qualification and public liability insurance.
- The childminder showed an understanding of the importance of working in partnership with parents and other early years settings children attend. This enables her to support children's individual needs. The childminder shared how she had previously used a daily diary with parents to share information about children's routines and activities during the day.
- The childminder has completed an early years qualification at level 3 since her last inspection. She demonstrated a clear understanding of how children learn and explained how she would plan play activities that take into account the children's interests and stage of development. She recognises the importance of adapting the play activities to enable all children to be included.
- The childminder is aware of her role to assess children's progress and shared the systems she would use to help her monitor children's achievements.
- The childminder has considered ways to review her childminding provision to help her to continue to develop the play and learning experiences she offers children.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector viewed the spaces, toys, resources and equipment available for use.
- The inspector talked with the childminder about her childminding responsibilities to keep children safe and healthy, and how she plans to provide activities for children to help them progress.
- The inspector read relevant documents, checked the childminder knows what records she needs to keep and the policies and procedures she must have.
- The inspector checked the childminder's understanding of how to improve her provision.
