Summary of key findings for parents

This provision is good

- Staff plan a wide range of daily activities and experiences that promote children's learning in all areas. Children benefit from lots of time and space to develop their play and learn through their own interests.
- Children settle well in the exceptionally nurturing and supportive environment. Staff sensitively foster very high levels of self-esteem. This ensures children are independent, active learners who are confident to play and explore.
- The staff team work effectively with parents. They gather good information about children at admission and continue to exchange information so that they can provide for children's individual needs.
- The manager has developed policies and procedures that promote children's well-being. As a result, staff use effective risk assessments for all areas of the nursery and any outings keep children safe and secure at all times.
- The manager and staff show a secure commitment to improving their practice. They make effective use of their self-evaluation systems and training opportunities to continually develop their knowledge and skills.

It is not yet outstanding because:

Staff do not consistently promote children's knowledge of early mathematical ideas. As a result, children do not always gain a secure understanding of shape, size and measurement.



What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

strengthenopportunities to promote children's understanding of early mathematical ideas, in particular shape, size and measurement.

- The inspector observed children and staff at a range of activities in the indoor and outdoor areas.
- The inspector looked at a sample of policies, children's learning records and planning documentation.
- The inspector held discussions with the manager and spoke to staff throughout the inspection.
- The inspector checked evidence of suitability and qualifications of the staff and read the self-evaluation document.
- The inspector took account of the views of parents spoken to at the inspection.

Inspection findings

How well the early years provision meets the needs of the range of children who attend. This is good

Staff use their secure knowledge of how the children learn to plan activities and experiences that meet their individual needs and interests. Children delight in learning about the natural world as they freely explore and investigate during the extensive outdoor play. Staff make very good use of their conversations with children to help them to learn new vocabulary. For example, staff make good use of the music and sound session. They introduce new words to the children who name the different sounds and instruments. Children are developing confidence in counting which they do during a range of activities. Staff's ongoing support of the children ensures they are gaining good skills for the next stage in their learning.

The contribution of the early years provision to the well-being of children is outstanding

Staff provide an exciting and exceptionally welcoming environment where children confidently play and explore. Children develop extremely warm, nurturing relationships with staff which ensures children feel valued and emotionally secure. As a result, they are exceptionally confident and enthusiastically engage with the activities. Staff are proactive in helping children to understand the importance of being healthy. Children have extensive opportunities for outdoor play, exercise in the fresh air and use good hygiene routines. Staff promote positive behaviour very successfully through a calm, sensitive approach and the excellent use of thoughtful strategies. Children play in a very safe environment where they are extremely well supported to learn how to manage their own safety. Children are happy and remarkably well settled. This ensures they develop exceedingly high levels of personal independence. Consequently, children are rapidly gaining the confidence and self-assurance needed for moving on to school.

The effectiveness of the leadership and management of the early years provision is good

The manager and staff team show a clear understanding of the requirements for the Early Years Foundation Stage. Consequently, children's learning and well-being are successfully promoted in all areas. The staff team's effective organisation means that all procedures are in place and well used to keep children safe and protected. The staff team makes good use of training and ongoing evaluations of their practice. As a result, since their last inspection they have developed a system of close monitoring of children's learning. This ensures all staff are able to all fully support children's different needs and abilities, and sustain very good progress for all children. Staff build strong relationships with parents through a good exchange of information. As a result, they have a secure understanding of children's current abilities and can support learning both at home and in the nursery.

Westwood Nursery School has been open since 1984 and registered with Ofsted in 2001. It is situated in Upper Westwood, close to Bradford-on-Avon. The nursery opens weekdays from 8.45am to 3pm during school terms. The nursery committee employ four members of staff; all staff hold early years qualification at Level 3. The manager holds a degree in early years childcare. The nursery provides funded early education for two, three and four-year-old children.
