## Summary of key findings for parents

### The provision meets requirements

- The childminder knows how children learn and understands the importance of finding out about their individual preferences and abilities. She is able to plan interesting activities that challenge children so they make good progress and become keen learners.
- The childminder is well-organised and values partnership working with parents and others. She has systems and documentation in place for sharing information between all those involved with the children's care and learning to ensure consistency.
- The childminder makes a detailed evaluation of her childminding service which enables her to continuously improve it. She is proactive in continuing with her professional development and has addressed the recommendations raised at her last inspection.
- The childminder has a secure knowledge of how to safeguard children's welfare and support their well-being. She has attended a variety of training and is very confident that she can address and recognise issues in order to protect children.
- The childminder has a positive attitude towards providing a service that includes all children. The childminder does not discriminate and plans activities that embrace all cultures and abilities, to promote a culture of respect and understanding.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
