Summary of key findings for parents

This provision is good

- Children thoroughly enjoy their time at the club. They are motivated to learn and take part in a variety of adult-led and child-chosen activities. Consequently, they behave well and learn good social skills.
- Staff share information regularly and hold meetings with the children's teachers to check children's progress. They discuss what children have been doing in school as well as any concerns. This provides good continuity of care and support for children's ongoing learning.
- Staff promote healthy lifestyles well. Children are offered a good range of healthy and nutritious snacks. They are encouraged to try new foods. Children learn about the importance of eating well.
- The provider has a secure understanding of the safeguarding and welfare requirements of the Early Years Foundation Stage. Effective supervision and training procedures are in place. Therefore, staff have a secure understanding of their roles and responsibilities from the very start.

It is not yet outstanding because:

- Strategies to encourage parents to share information, about what their children like and can do at home, are not always successful. Consequently, some children's needs are not as well planned for when they first start.
- Some resources are stored in boxes, which are not always labelled. Consequently, the youngest children do not always know what resources are available to them. This reduces the independent choices they are able to make about their play.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- review and enhance systems for gathering information from parents about children's starting points at the earliest opportunity, to enable key persons to plan for children's next steps in learning as soon as possible
- ensure all children know what resources are available, for example, by labelling boxes that resources are stored in.

Inspection activities

- The inspector observed the quality of teaching and the impact this has on children's learning, both inside and outdoors.
- The inspector held a meeting with the provider, spoke with staff and children and took account of the views of parents spoken to on the day.
- The inspector looked at children's records and planning documentation.
- The inspector checked evidence of the suitability and qualifications of the staff working with children and the provider's self-evaluation form.

Inspection findings

How well the early years provision meets the needs of the range of children who attend. This is good

There is a strong emphasis in the club on play and having fun. Staff gather some information from parents about children's achievements on entry. However, the ways in which they do this are not always successful. Consequently, staff do not always plan effectively for all children from the start. Nevertheless, the quality of teaching is good. Children are engaged well. Staff provide age-appropriate challenges for them to undertake. Children enjoy taking responsibility for specific jobs, such as setting the table for snack. Children are encouraged to use simple mathematics during these everyday activities. They add together the amount of boys and girls to ensure everyone is included. They talk about left and right when setting out cutlery and discuss the size of the small, medium and large cups. Children relish the praise awarded to them for their efforts. These effective teaching strategies ensure children's continuing progress is fully supported.

The contribution of the early years provision to the well-being of children is good

Staff are very approachable and parents have a lot of confidence in them. The key-person system is established. Children's emotional well-being is promoted effectively and their individual care needs are identified and met well. Children are confident in their surroundings. However, resources are not always effectively labelled. Consequently, the youngest children are not always independent when choosing what to play with. Children write letters and enjoy talking about their family members. They enjoy using a wide variety of media to be creative. Staff offer support when needed and engage children in meaningful conversations. This helps children to concentrate. They communicate confidently as they describe their drawings and talk about things that interest them. Staff give praise for their efforts. Staff share information with colleagues, which ensures plans for future care and learning continue to meet children's needs. Children regularly access the outdoors. Staff participate in group games. This positively encourages children to enjoy physical activity.

The effectiveness of the leadership and management of the early years provision is good

Children are safeguarded effectively and the provider makes sure that safeguarding training is regularly updated. Therefore, staff fully understand the procedures to follow if they are concerned about children in their care. A good range of policies and procedures are in place. This supports staff's understanding and practice. Since the last inspection, the provider has made vast improvements. They have taken targeted and effective action to address all previously identified weaknesses. For example, robust vetting processes have been implemented for new staff and accurate records kept. Effective supervision and coaching is now in place. The provider and staff are committed to raising outcomes for children. Good systems for reflecting on practice are in place, to ensure the club continuously develops. The well-qualified staff are enthusiastic and work well together, which promotes children's continued progress in learning. Partnerships with parents and other professionals are established.

Boughton Early Birds operated by TJ Daycare out of school club was registered in 2011. It operates from Boughton Primary School, in the village of Boughton, Northampton. The club employs five members of childcare staff. Of these all hold appropriate early years qualifications at level 3 and above, including the provider with Qualified Teacher Status. The club opens from Monday to Friday, during term time only and serves the children attending the school. Sessions are from 7.45am to 9am and 3.30pm to 6pm, apart from Friday when sessions end at 5.30pm.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register.
