## Summary of key findings for parents

#### The provision meets requirements

- Staff understand how to safeguard children. They ensure children's safety by appropriately supervising them, and by completing risk assessments on the environment to identify and address potential hazards. In addition, staff know the child protection procedures to follow if they have concerns about a child's welfare.
- Staff are aware of how to plan activities that include children's interests and support their continued development.
- Staff promote children's health and awareness of healthy lifestyles. They provide healthy snacks, children can freely get themselves fresh drinking water and have plenty of exercise outdoors.
- The manager and staff reflect on their practice regularly. They include children views in their evaluations of activities to help identify where they can drive improvements, and discuss what training is required to update their knowledge and skills.
- Staff have taken action to successfully address the recommendations set at the last inspection. As a result, children now have access to a good range of books and puzzles that help promote their understanding of diversity and difference.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

### **Inspection activities**

- The inspector observed staff interacting with older children within the main hall.
- The inspector looked at a sample of policies and procedures, including safeguarding, complaints and behaviour management.
- The inspector held discussions with the manager and staff regarding safeguarding practice.
- The inspector held discussions with the manager and staff regarding the support for children in the early years age group.
- The inspector spoke to parents and staff to gather their views.

Bromley Mytime at Red Hill Primary School was registered in 2005. It operates from Red Hill Primary School within the London Borough of Bromley. The club is open each weekday from 3pm to 5.45pm. There are three members of staff who work with the children, of these two hold relevant childcare qualifications, the manager holds one at level 3, and the deputy one at level 2. There were no children on roll in the early years age range at the time of the inspection.
