Summary of key findings for parents

This provision is good

- Staff provide children with a wide range of resources and interesting activities, which ensures they are interested and enjoy their time at the club.
- Staff are caring, sensitive and provide a nurturing environment. Consequently, children have good relationships with staff and their behaviour is good.
- Staff have a good understanding of their roles and responsibilities to safeguard children. They demonstrate a secure understating of the procedures to follow should they have a concern about a child in their care. This means children are safe and secure at the club.
- Positive partnerships with the school teachers and parents promote a consistent approach to supporting children's care.
- Risk assessment, together with effective supervision, helps to keep children safe during their time at the club. The premises are secure and staff monitor the arrival and departure of parents to ensure children remain safe.
- Leaders monitor the quality of the provision and the activities and experiences offered to children to ensure that the staff respond to the children's needs and different ages.

It is not yet outstanding because:

Staff do not always plan daily routines to enable younger children to develop their independence and self-help skills, particularly at snack times.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

encourage younger children to further develop their independence and self-help skills through providing more opportunities for them to take part in daily routines.

- The inspector observed the range of resources and activities on offer to the children.
- The inspector observed the staff's interaction with the children.
- The inspector spoke to the children and staff present, and held a meeting with the club leader.
- The inspector took account of parents' and children's feedback about the club.
- The inspector viewed a sample of paperwork, including records of suitability and policies and procedures.

Inspection findings

How well the early years provision meets the needs of the range of children who attend. This is good

Staff are committed to providing children with good-quality care and play. As a result, the quality of staff interactions with the children is good. Staff provide good challenges for children to ensure they are occupied and enjoy their time at the club. For example, there are good resources to support children's understanding of technology and they use the school's computers to enhance their skills. Children thoroughly enjoy their time at the club because they take part in activities which interest them, such as playing with farm toy sets. Staff discuss the needs of the children with their parents and teachers. This helps to support children's care routines effectively. Staff regularly receive and share what they know about the children and find out what topics they are covering in school. Children's ideas are valued and included in the planning of activities. For example, after teatime, children help to decide some of the activities they would like to participate in. As a result, children enjoy their time at the club.

The contribution of the early years provision to the well-being of children is good

Staff gather a range of information about children's likes and dislikes from the parents when children start. This ensures that staff are able to meet children's needs. As a result, children are happy and form close relationships with staff and other children. Older children are caring and considerate towards the needs of the younger children, which helps them to feel settled and secure. During snack time, staff take time to engage children in conversations that foster their confidence and communication skills. Staff provide children with plenty of opportunities to exercise and enjoy nutritious options at snack times. As a result, children learn how to be healthy.

The effectiveness of the leadership and management of the early years provision is good

The provider has a good understanding of her responsibilities. Recruitment and vetting procedures are well established to ensure the suitability of all staff. Disclosure and Barring Service checks are completed for all staff working with the children. Staff have opportunities for regular supervisions and appraisals. These enable staff to identify their own training needs and discuss the children in their care. Partnerships with parents are good. Staff exchange information with parents to promote continuity of care. Staff complete daily evaluations on the activities they offer to children and regularly monitor the provision in order to identify areas for improvement. This helps to ensure that improvement plans are targeted at areas which need improvement and maintains continuous development of the provision.

The Have Some Fun Kidz Club operates from a large school hall in St Paul's Cray, Kent. The club is open each weekday, from 3.15pm to 6pm, for 38 weeks per year. The club employs six members of staff, of whom four hold relevant qualifications at level 3.
