- The childminder promotes children's self-esteem in her interactions with children, who develop high levels of independence and confidence. This prepares them very well for their future learning at school.
- The childminder teaches children exceptionally well why it is important to share with their friends. As a result, children play cooperatively with each other and form firm friendships.
- The childminder, co-childminder and their assistants are dedicated to ensuring the continuous improvement of the educational programmes offered. All strive to offer children excellence in the service they offer children and their families.

Inspection findings

How well the early years provision meets the needs of the range of children who attend. This is outstanding

Children make excellent progress in their learning and development. The childminder demonstrates her first-rate skills as she plays alongside children and extends their learning at every possible opportunity. She provides an enabling environment that captures children's interest and fuels their imagination. They learn about different countries and festivals happening around the world and see themselves represented in photographs of recent activities and exciting outings. Children eagerly discuss which foods are their favourites as they role play shops with the childminder and assistant. A mixed group of boys and girls talk about their home lives as they pretend to shop so they can make dinner for each other. They use their imaginations, using an impressive range of natural materials and real objects to extend and develop their play exceptionally well. They confidently count and recognise familiar numbers and letters in their environment as the childminder teaches them through fun activities both inside and outside in the garden.

The contribution of the early years provision to the well-being of children is outstanding

The childminder is exceptionally skilled and sensitive and helps children to form strong emotional attachments so they are secure within the setting. She has an excellent knowledge and understanding of each child, which has an extremely positive impact on their physical and emotional well-being. This enables them to develop as confident learners who feel valued and included, and experience a real sense of belonging. Children enjoy exceptionally healthy and nutritious meals that the childminder plans to take account of their specific dietary requirements. They thoroughly enjoy mealtimes as the childminder sits with her key children and makes this an extremely sociable time. Superb partnerships exist between children's parents and the childminder. All children's needs are exceptionally well met and parents engage readily in their learning through highly successful links.

The effectiveness of the leadership and management of the early years provision is outstanding

The childminder follows robust recruitment procedures to rigorously assess the suitability of all new assistants or students on work experience. She fully understands the procedure to follow to report concerns about the welfare of children. Detailed safety checks of the premises and garden contribute significantly towards the children's safety. The childminder engages with parents extremely well. Parents stated how much they value the childminder and her co-workers. They commented on the close, community feel of the setting and how this helps to make them and their children feel safe and secure. The childminder uses self-evaluation as an opportunity to seek the views of parents, children and her assistants. She has identified clear areas for improvement and has high ambitions to continue to improve the already exceptional quality of her setting.
