Monitoring for provision judged as inadequate

An Ofsted inspector, Pauline Nazarkardeh, monitored your provision on 21/05/2015 following your inspection where the provision was judged to be inadequate.

Outcome of monitoring

As a result of our inspection on 02/02/2015, we sent you a welfare requirements notice. If you were set actions at the inspection, or as a result of our subsequent monitoring or investigations, these are included at the end of this letter.

On 12 March 2015 we found that you had met the welfare requirements notices set at the time of inspection.

A monitoring visit was carried out on 21 May 2015 to assess if improvements had been sustained and we found that you had taken prompt and effective action since the inspection, the welfare requirements notices and notices to improve issued continue to have been met.

The systems in place to safeguard children had improved, you have undertaken training and you were aware of the procedure to follow should you have a concern about a child in your care. In addition training had been provided for staff on how to identify and report any future safeguarding concern they which may arise. As a result of the improvements children were better protected.

You had improved on your documentation which now includes records of children's arrival and departure times. In addition a more robust system was in place to assess the suitability of those having access to the children.

Regular supervisions of staff were in place, giving opportunities for staff professional development. Staff were more involved in decision making about the necessary

changes in the nursery.

You had made improvements to the systems to plan and assess children's progress. The nursery had regular input from the local authority development worker to help bring about the necessary improvements.

Having considered all the evidence, the inspector is of the opinion that the setting has taken prompt and effective action to address the points for improvement.

Next steps

The next step will be a full inspection.
