The setting does not meet legal requirements for early years settings

## Summary of key findings for parents

#### The provision does not meet requirements

- The childminder understands how to protect children but does not share her safeguarding procedures with parents. In addition, she does not have the written safeguarding statement needed to meet the requirements for the Childcare Register.
- The childminder does not have valid public liability insurance, as required. This is also a breach of requirements for the Childcare Register.

Previous inspection:

Good

- The childminder has a suitable understanding of the learning needs of children and, as a result, plans activities that challenge them to enjoy their learning.
- The childminder knows how to monitor and reflect on her practice. She has used the views of children who have previously attended to improve the childcare practice.
- The childminder keeps her first-aid training up to date. This means she is able to manage accidents in a suitable manner.
- The childminder understands the importance of promoting healthy lifestyles. She knows to offer children a fresh, varied diet and opportunities for fresh air and exercise.
- The childminder explains how she records relevant details of any children she cares for and uses this information to help them feel safe and secure as they settle.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

### What the setting needs to do to improve further

#### To meet the requirements of the Early Years Foundation Stage the provider must:

- share information with parents about the procedures to safeguard children
- ensure public liability insurance is in place.

#### To meet the requirements of the Childcare Register the provider must:

- keep and implement a written statement of the procedures to be followed for the protection of children, intended to safeguard children being cared for from abuse and neglect (compulsory part of the Childcare Register)
- obtain insurance in the respect of liability which may be occurred for death, injury public liability, damage or other loss (compulsory part of the Childcare Register)
- keep and implement a written statement of the procedures to be followed for the protection of children, intended to safeguard children being cared for from abuse and neglect (voluntary part of the Childcare Register)
- obtain insurance in the respect of liability which may be occurred for death, injury public liability, damage or other loss (voluntary part of the Childcare Register).

#### **Inspection activities**

- The inspector checked a sample of the documentation that the childminder uses to support her work.
- The inspector and the childminder discussed the systems to observe and record the children's progress.
- The inspector and the childminder discussed the childminder's self-evaluation systems and her plans to improve her practice.
