Summary of key findings for parents

This provision is good

- The childminder implements the requirements of the Early Years Foundation Stage effectively. This safeguards children and ensures they progress well toward the early learning goals.
- The childminder offers children good care and education and is a positive role model. This means children are confident, motivated, and their physical and emotional needs are met well.
- The childminder has completed further training to improve her knowledge of childcare. Therefore, children's outcomes are improved.
- The childminder updates parents about their children's progress and provides continuity of care for siblings. This ensures good parental partnerships are developed.
- Children make good progress in their learning because of the childminder's effective teaching methods.

It is not yet outstanding because:

■ The childminder does not take all opportunities to extend children's understanding of early writing skills. For example, she does not always offer children a range of writing tools and resources.

Inspection findings

How well the early years provision meets the needs of the range of children who attend. This is good

The childminder undertakes observations and assessments of children when they start. This helps her to provide all children with the best learning opportunities for their age and stage of development. The childminder effectively promotes children's language, and emotional and social skills. Children enjoy talking about various animals as they play with the farm resources. The childminder asks challenging questions, for example, to find out if children can identify and find specific animals. This extends their learning and they become skilled at sorting and matching, promoting mathematics. The childminder effectively promotes children's physical development. For instance, children enjoy play in the garden with bikes, scooters and role play resources. Children's knowledge of the world is promoted well. For example, they feed the pet rabbit and learn to take care of her. Children also enjoy building towers with bricks and quietly looking through books.

The contribution of the early years provision to the well-being of children is good

The childminder teaches children about good behaviour and as a result they behave well. She also helps them to learn about diversity and positively promotes their cultures. For example, she speaks to children in their home languages. The childminder provides resources reflecting positive images of diversity and celebrates various festivals. The childminder promotes children's good understanding of healthy lifestyles. She offers nutritious drinks and snacks outside in the sunshine. Children learn to successfully manage their personal needs. The childminder implements good care practices, such as toilet training and hand washing. The childminder promotes children's awareness of safety. She talks to them about road safety when she takes them on trips. The childminder effectively prepares children for school. For example, she takes them to visit the local schools. She ensures children develop across all the areas of learning so they are ready for school.

The effectiveness of the leadership and management of the early years provision is good

The childminder has a good understanding of safeguarding procedures. She knows how to identify and report any concerns to the relevant agencies. This effectively maintains children's well-being. The childminder carries out risk assessments to enable her to identify and remove any risks to children's safety. The childminder has met the actions from the last inspection, driving improvement. She evaluates her practice well, so that children benefit. For example, she has increased the range of activities and resources she offers to children. The childminder effectively supervises her assistant and knows how to work with external agencies to provide a shared approach.
