Summary of key findings for parents

The provision meets requirements

- The childminder's home is free from hazards secure with necessary facilities including well maintained toys to promote children's development and learning.
- The childminder understands the child protection procedures approved by the Local Children Safeguarding Board and how to put the procedures into practice.
- The childminder has a clear understanding of managing children's behaviour appropriately and consistently to promote their welfare and development.
- The childminder knows how to promote the good health of children. For example, through daily cleaning routines to minimise cross infection, cooking nutritious meals that comply with children's dietary needs and regular physical activities.
- The childminder understands the importance of working in partnership with parents and other carers to meet the developmental and learning needs of the children.
- The childminder knows how to observe and assess children's abilities to identify their achievements, areas for support and progression. The childminder has a good range of toys and offers activities to support children's learning.
- The childminder understands the process for self-evaluation and meeting previous recommendations to help improve her practice. She has attended some training courses to update her knowledge of childcare.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector had discussions with the childminder about her childminding practices.
- The inspector observed the whole of the ground floor area accessible to children and toys.
- The inspector looked at a range of documentation, including policies, attendance and accident book and a sample of an activity plan.
