This inspection

This home was judged outstanding at the last full inspection. At this interim inspection Ofsted judge that it has **sustained effectiveness**.

There were no requirements or recommendations made at the last inspection. The registered manager continues to creatively develop the service. A new social work aspect of the short breaks service, 'with a goal to create a multi-disciplinary team that can deliver support to prevent crisis situations and make life ordinary for young people' is being established as an extension to the existing additional services.

The registered manager undertook health and safety improvements to the accommodation for young people, including the purchase of new cupboards and hoists in the bedrooms. To assist the children and young people that have difficulty accessing the service due to transportation issues, the service has obtained a mini people carrier. The mini bus can be driven by any member of staff with a valid driving licence and requires no further training. Parents will be able to arrange collection and drop off times with the staff, ensuring children young people have continuous access to the service.

To promote staff development the registered manager has reviewed the appraisal process for staff which now encourages them to provide their own analysis of their ability to care for children and young people and identify for themselves areas of professional development.

The independent visits and reports for the service are conducted by more than one independent visitor. To improve the level of consistency among the different independent visitors and ensure an evaluation of how the service improves outcomes for children and young people, the registered manager has revised the current report format in light of the new regulations in force from 1 April 2015.

Children and young people continue to be safe and well cared for while staying at the short break service. The service continues to maintain positive working relationships with parents and professionals who speak highly of the service. A parent emailed the registered manager to express their 'extreme gratitude and thanks to the staff for the support and the great impact the service has had on their child, which has made life easier.'

Information about this children's home

This children's home is a resource centre for children with disabilities and their families and is owned and managed by the local district council. One of the services offered at the centre is residential short break care for children with a disability. It is this aspect of the centre's activity that is regulated under the Children's Homes Regulations 2001. The centre is registered for five young people aged between eight and 17 years who have a learning and/or physical disability; many of the children also present challenging behaviour. Other services offered include day care, after school care, outreach services and a domiciliary care service registered with the Care Quality Commission.
