Summary of key findings for parents

The provision meets requirements

- The childminder understands the learning and development requirements. She has a good range of resources to meet the needs and interests of children of different ages, abilities and backgrounds.
- The childminder has a good understanding of promoting children's physical and emotional well-being. She understands how to provide children with opportunities to play and learn outdoors. She knows the importance of encouraging healthy eating and of providing opportunities for children to socialise and form strong attachments to her.
- The childminder meets the safeguarding and welfare requirements and knows how to implement these. She holds a current first-aid certificate.
- The childminder has a good understanding of how to look after children, meet their physical needs, and keep them safe and in good health.
- The childminder recognises the need to risk assess her premises and have emergency evacuation procedures. She has a range of policies to help ensure children's welfare is protected.
- The childminder recognises the needs to improve her service through ongoing evaluation and professional development. She is currently undertaking a relevant qualification.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector discussed with the childminder how she plans to meet the learning, development and assessment requirements, and the safeguarding and welfare requirements.
- The inspector observed the spaces, toys, resources and equipment available for childminding purposes.
- The inspector discussed what documents the childminder plans to keep when caring for children, together with her policies and procedures.
