Summary of key findings for parents

The provision meets requirements

- The childminder has a good understanding of the learning and development requirements. She knows how to plan activities to take account of children's individual needs and interests.
- The childminder has highly effective systems to observe and assess children's individual progress. She knows how to involve parents to gather information and identify starting points and next steps for children.
- The childminder has a good selection of resources. She has clear understanding of how to use resources to engage children's interest and provide them with stimulating and challenging play experiences.
- The childminder knows how to promote a healthy lifestyle by providing children with healthy snacks and meals. In addition, she understands how to promote their physical development through a range of well-planned activities, both inside and outdoors.
- The childminder offers a safe and welcoming environment. She understands the importance of completing risk assessments to ensure children are safe and well protected in her home and on outings. She has a clear understanding of the procedures for safeguarding children and knows how to refer any concerns.
- The childminder demonstrates a strong commitment to continuously developing her skills and knowledge. She attends training courses and reflects well on her practice to improve the quality of provision for children.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector looked around the childminder's home and at the resources available for children.
- The inspector discussed with the childminder how she intends to provide a range of activities and experiences for children to support their learning.
- The inspector talked with the childminder about how she keeps children safe and protects them from potential harm.
- The inspector reviewed the childminder's policies and documentation, including those for assessing children's development and for safeguarding.
