- The childminder's home is free from hazards and secure. She knows to be vigilant and has procedures to help ensure potential hazards to children on the premises and outside are minimised.
- The childminder has a suitable range of furniture, equipment and toys that are safe, maintained to good condition and developmentally appropriate for children.
- The childminder understands child protection issues and the procedures to follow if she has any concerns about a child being at risk of harm. She also knows to keep certain required documentation to safeguard children's welfare.
- The childminder knows how to implement good hygiene practices to minimise the spread of infection.
- The childminder understands how children learn and how to promote children's learning through play.
- The childminder knows to observe, assess and keep a record of children's abilities in order to monitor how well children progress across the areas of learning.
- The childminder understands the importance of working in partnership with parents to meet children's individual needs and the continuity of their care and learning.
- The childminder has completed a number of training courses to keep up to date with current procedures. She has a positive approach to improvements in her childcare practices.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
