Summary of key findings for parents

The provision meets requirements

- The childminder observes children frequently in order to plan activities which engage the interests of children. As a result, this meets their individual needs.
- The childminder provides children with a vast range of resources that they can access independently. This enables them to take the lead in their own play and learning experiences.
- The childminder has effective strategies and resources to support the needs of children with English as an additional language. This helps to ensure that all children make good progress in their learning based upon their starting points.
- The childminder knows the procedures of how to safeguard children to keep them safe from risk of harm, which promotes children's welfare.
- The childminder attends local groups regularly to ensure children socialise with other children. Consequently, this promotes children's awareness and confidence skills.
- The childminder maintains positive partnerships with parents, involving them in children's well-being and learning. This promotes consistency and enables her to meet the individual needs of children.
- The childminder continues to develop her professional practice through regular training and through her additional role as a lead childminder at the local Children's Centre. This enables her to continually improve the outcomes for children.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

- The inspector viewed the areas of the home used for childminding.
- The inspector discussed and questioned practices and routines with childminder.
- The inspector looked at the childminder's documentation, including the policies she has regard to when childminding.
