### **Inspection findings**

# How well the early years provision meets the needs of the range of children who attend. This is good

The childminder has a firm understanding of the Early Years Foundation Stage, and as a result, the quality of teaching and learning in good. The childminder observes children in all areas of learning, so that she is able to monitor their milestones and assess their progress. Children develop their communication and language skills through discussions and repeating spoken words. Children enjoy answering questions to explain their preferences, such as what they like best about their food. Children enjoy playing with small world models. For example, they learn some basic number words when they count how many trains they have and whether these are big or small. Children develop their creativity through well-planned art and craft activities. They make musical shakers from household items and dried foods, and explore the differences in the sounds of traditional musical instruments.

# The contribution of the early years provision to the well-being of children is good

The family orientated environment nurtures strong attachments with children. Children are happy and settled. They learn the difference between right and wrong in everyday routines. Children feel proud of their achievements and thrive on the childminder's praise. Although children's parents provide meals, with prior agreement, children also enjoy eating traditional, home cooked, nutritious Asian foods. Children take part in daily physical activities to promote their good health and develop their physical skills, such as playing in the garden and joining in with 'Rhyme Time' at the local library.

# The effectiveness of the leadership and management of the early years provision is good

The childminder demonstrates a strong commitment to continuous improvement. This is because effective use of self-evaluation means that previous recommendations have been addressed. The childminder maintains a good two-way flow of communication with parents. She arranges parent meetings, completes daily diaries to exchange information about babies and regularly shares children's observations and assessments. This provides ongoing opportunities for parents to contribute to children's learning and development, including information gained from the children's two-year-old progress checks. The childminder is professional in her approach to childminding. She attends courses to support her continual development and to promote good outcomes for children.
