### Summary of key findings for parents

#### The provision meets requirements

- Management understand the need to provide activities and resources to complement children's learning at school and cater for their individual interests.
- Staff know how important it is to help new children settle in and feel safe and secure when at the club.
- Staff understand how to teach children about healthy living, by providing nutritious food and physical play activities, both indoors and outside.
- Staff understand the need to teach children how to manage their behaviour and learn to respect other people's feelings.
- Management understand how to safeguard children. They know the local authority's safeguarding and child protection procedures. Staff understand their role in protecting children's well-being and welfare.
- The manager knows to regularly evaluate and reflect on the procedures and practices of the provision. These are used to effectively drive improvement for children.
- The required records and paperwork are in place and kept up to date, this helps to further safeguard children's welfare and well-being.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

#### **Inspection activities**

- The inspector sampled a range of paperwork and discussed these with the manager. Discussions included the provider's safeguarding and child protection procedures, complaints policy and how children's good health is maintained.
- The inspector looked at the range of toys and activities available to the children.
- The inspector held discussions with the provider.
- There were no early years children present at the time of inspection.

Kindergarten Kids Ltd Afterschool Club registered in 2007. There are six other settings owned by this provider. It operates from St. Alphege, Church of England Infant School in Whitstable, Kent. The provision is open 3pm to 6pm, weekdays, term times only. The club employs two staff and the manager has a recognised childcare qualification. There were no children present in the early years age range at the time of the inspection.
