Summary of key findings for parents

The provision meets requirements

- The childminder has a secure understanding of her role in safeguarding to help to protect children. She is confident in the procedures to follow if she has any concerns about their welfare.
- The childminder recognises how to encourage children to keep safe. She holds public liability insurance, a valid first-aid certificate and conducts suitable risk assessments of her setting to minimise any potential hazards. The childminder knows how to teach children to identify risks, while maintaining their safety.
- The childminder has a suitable understanding of the learning and development requirements. She knows how to observe, assess and monitor children's development to encourage their continuing progress from their starting points.
- The childminder has a broad range of toys and resources available that cover all areas of learning and understands how to plan a wide range of outings for children to experience the wider world.
- The childminder understands how to manage children's behaviour in a positive way, including helping them to make friends.
- The childminder continues to develop and evaluate her practice to improve the care and learning for children. She has attended training and consults with other childminder's to support her in meeting children's needs.
- The childminder knows how to develop a good partnership with parents to ensure she knows and meets the individual needs of the children.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector reviewed the childminder's training certificates along with a sample of documentation, including policies and improvement plans.
- The inspector discussed with the childminder how she intends to deliver the educational programme for children.
- The inspector and the childminder toured the areas of the childminder's home that she uses for childcare.
- The inspector and the childminder discussed and looked at a selection of resources and equipment.

The childminder registered in 2000 and lives in Chalfont St Giles, Buckinghamshire. The childminder operates all year round from 7.30am to 6.30pm, Monday to Friday, except for bank holidays and family holidays. At the time of this inspection, there were no children on roll in the early years age range.
