

# Mechinoh School

#### **Context of the inspection**

- This inspection was undertaken at the request of the registration authority for independent schools in order to monitor the progress the school has made in implementing its action plan.
- The school received a standard inspection in November 2013.
- In January 2014, the Department for Education (DfE) formally notified the school that it must respond to the weaknesses identified at that inspection. The school submitted an action plan responding to the weaknesses identified in the inspection in November 2013. This was submitted in the form of a letter to the DfE in February 2014. The evaluation of the plan found that it required improvement with most proposed actions and timescales not being reasonable. The rejection of the action plan was confirmed to the school by the DfE in February 2014.
- The school received a standard inspection in November 2014. A progress monitoring inspection was carried out on day 3 of the standard inspection. Standards relating to parts 3, 4 and 5 of the appropriate Education (Independent School Standards) (England) Regulations 2010, as amended, were not met.
- In March 2015 the DfE issued a decision to Mechinoh School to remove the school from the register of independent schools. The school has appealed against the decision.
- This progress monitoring inspection was commissioned by the DfE on 22 May 2015 in order to ascertain whether or not the school has rectified the failings and the extent of the progress made. Specific regulations that inspectors were asked to report on were parts 3, 4, 5 and 8 of The Education (Independent School Standards) Regulations 2014.
- The school has not submitted an action plan responding to the weaknesses identified in the inspection in November 2014.
- One of Her Majesty's Inspectors was in school for one day in order to conduct the present inspection. The inspector had a background in education including independent schools.

#### **Main findings**

#### ■ Part 3. Welfare, health and safety of pupils

The inspection of November 2014 found that the school's leaders had not been robust enough in their attempts to ensure arrangements made to safeguard and promote the welfare of students at the school were strong. Consequently, standards relating to the well-being of students were not met.

Leaders' actions to ensure that students, staff and visitors are safe have not been effective enough since the last inspection. The inspector found that the basement fire escape route remained blocked by a bolted door. Fire evacuation procedures make provision for the basement fire escape door to be opened by an adult in the case of an emergency. This is unacceptable. Leaders are not in a position to guarantee that a teacher will always be present in the basement to open the door for students. Also, one of the bolts is positioned at the top of the door and the other at the bottom, these could be difficult to find, reach and/or open for some students, especially in an emergency. Leaders acted swiftly, during the inspection, to reinstate a second floor emergency exit route as a means of escape in case of fire on or near the stairs around the first floor. However, this escape

route has not been recorded in the fire evacuation procedure and staff and students have not been trained in its use.

Leaders have reviewed the first aid policy, which previously had a number of omissions. The policy now includes clear guidance on the actions to take if a student is injured or is ill. However, leaders are not in a position to guarantee basic first aid cover at all times because only one member of staff is trained in first aid.

Leaders have taken some appropriate steps to improve the welfare, health and safety of the students in the school since the last inspection. Leaders have undertaken, or commissioned, considerable work to rectify many of the faults relating to the maintenance of the grounds and building, identified at the last inspection. The perimeter fence is now secure with an electronic entrance gate through which the entrance of all visitors can be monitored. Where possible, the school grounds have been tidied and trip hazards removed. External safety lighting has been checked and repaired and in a few cases, such as around the basement fire escape, improved. The school building is much cleaner than at the time of the previous inspection. Cracked windows, along with plastic wall cladding, have been replaced, broken furniture has been removed and the basement floor has been cleaned and is now fit for use as a play area. Leaders have authorised extensive electrical testing and repair which has made electrical systems and appliances safe. Leaders have also sanctioned an extensive review and repair of the fire safety system and equipment. Many additional smoke alarms have been fitted while empty fire extinguishers have been refilled or replaced. A robust fire safety equipment monitoring system has been put in place by leaders. Leaders' records show that the fire alarm system is tested frequently. These actions are contributing to the well-being of students. However, the standard relating to the welfare, health and safety of pupils is not met.

#### ■ Part 4. Suitability of staff and proprietors

The inspection of November 2014 found that leaders had not ensured the suitability of all teachers because checks had not been thorough enough, record keeping was inadequate and the latest guidance in relation to keeping children safe in schools had not been followed systematically. The standard relating to the suitability of staff and proprietors remains unmet. Leaders have not yet taken action to register with the Employer Online Access Service nor have they completed prohibition from teaching checks for each teacher employed at the school. This means that students are inadequately safeguarded because appropriate pre-employment checks are incomplete.

Not all of the required pre-employment checks, for example prohibition from teaching checks and qualification checks, have been carried out and recorded in the single central record by leaders. Therefore, the single central record does not meet requirements.

The single central record includes the facility to record all the relevant pre-employment checks along with the dates they were carried out. All teachers working at the school are included in the single central record. Leaders have sought and received retrospective references for all teachers employed at the time of the last inspection. A significant minority of these references are of poor quality because they do not include sufficient detail about teachers' background, character and skills to enable leaders to make informed judgements about a teacher's suitability to teach. Leaders have introduced a school reference request form. This means that, for example in the case of the teacher most recently employed, leaders receive much more detailed information about the prospective member of staff than they did before the last inspection.

Leaders have carried out medical fitness checks on all teachers working at the school. Leaders have obtained information to satisfy themselves that the contract cleaner has been checked thoroughly by his employers. However, leaders have not included this member of staff on the single central record.

#### ■ Part 5. Premises of and accommodation at schools

The inspection of November 2014 found the school's provision of changing, washing, showering and toileting facilities for students was inadequate and that maintenance and cleaning standards were poor.

This remains the case overall because actions taken by leaders to improve the changing, washing

and toileting facilities for students have not been effective. Students do not have suitable on-site changing and showering facilities should they need them following a physical education lesson. As reported at the last inspection, the medical room is still not positioned near enough to a suitable toilet.

Leaders have taken appropriate action to ensure that all washrooms have an adequate supply of hot and cold running water. Leaders have installed electric water heaters in each washroom used by students. This is an improvement since the last inspection. Leaders have taken appropriate action to clear the disused chemical lab of all chemicals. While the area remains unfit for use by students, as reported at the previous inspection, the risk posed by stored chemicals has been eliminated.

All fire escape routes identified by leaders are free from clutter and rubbish such as broken furniture. The school's electrical supply fuse box has been encased in a locked cupboard and the gas supply is now housed in a locked room which is free from debris. Leaders use a daily health and safety check list to identify potential maintenance issues and take action to rectify problems. For example, all fire extinguishers have been refilled or replaced and none have been tampered with because of leaders' increased vigilance.

#### ■ Part 8. Quality of leadership and management

This standard is not met. Leaders do not take appropriate action to ensure the welfare, health and safety of pupils at the school are secure. Leaders' checks to ensure the suitability of staff are not robust enough. The premises and accommodation at the school are not adequate because facilities for changing, showering and toileting are not appropriate. Although leaders have taken action to make improvements in Parts 3, 4 and 5 of the regulations, gaps remain in each area.

#### Information about this school

- Mechinoh School was opened in 1982 and is situated in Salford, North Manchester. It offers secondary education for up to 73 Orthodox Jewish boys, aged between 11 and 16 years with provision for both religious and secular studies.
- There are currently 62 students on roll. There are no students with a statement of special educational needs. A very small number of students speak English as an additional language.
- The school aims 'to provide a comprehensive religious education for its students and to prepare them for entry into *yeshivas* (Talmudic Colleges) to further their religious education'. In addition, it aims 'to equip students with the basic skills required for adult life, such as literacy, numeracy and general knowledge whilst placing great emphasis on developing a high standard of ethical behaviour'.
- On leaving school, all students continue their education in *yeshivas* in the United Kingdom.
