Summary of key findings for parents

The provision meets requirements

- The childminder understands how to maintain a safe, welcoming, inclusive environment for children. She has a good variety of resources available to children that promote their development in all areas to help prepare them for school.
- The childminder has a clear understanding of how to implement the learning and development requirements. She knows how to use observation and assessment to aid planning for children's individual learning needs.
- The childminder has a sound understanding of how to safeguard children's welfare and support their well-being.
- The childminder knows how to work in partnership with parents and others to promote a consistent approach to meeting children's care and learning needs.
- The childminder evaluates her provision and has addressed both recommendations raised at her last inspection, which related to documentation. She has also updated her first-aid training and increased her resources, showing a drive to improve her provision for children.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

- The inspector discussed with the childminder how she meets the learning and development requirements when caring for children.
- The inspector looked at the childminder's documentation, including the policies she uses when childminding.
- The inspector observed how the childminder maintains a safe environment for children.
