Summary of key findings for parents

The provision meets requirements

- Leaders and managers have an understanding of the learning and development requirements of the Early Years Foundation Stage. This helps them plan suitable activities that will help promote all areas of children's learning.
- Leaders and managers provide support for children who speak different languages, which helps children to progress in their communication skills.
- The children are provided with opportunities for regular physical exercise, promoting their growing awareness of healthy lifestyles.
- Leaders and managers reflect on the quality of the nursery by identifying strengths and key weaknesses, and using these to plan for improvement. This process has highlighted the need to update training on a regular basis to keep abreast with changes.
- Leaders and managers have an understanding of the safeguarding and welfare requirements. They are able to describe signs and symptoms of abuse and understand the Local Safeguarding Children's Board procedures to follow if they had a concern about children's welfare.
- Leaders and managers complete risk assessments to ensure children are able to play safe and secure environment.
- Although there are suitably qualified staff ready to transfer from another setting when children attend, there are currently no staff working at the setting as there are no children on roll.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector discussed with the nominated person how he plans the educational programmes, assesses children's abilities and plans for their progress, meets the safeguarding requirements and works with parents.
- The inspector discussed the policies and documentation the nursery will use when caring for children.
- The inspector discussed how the nominated person reflects on practice and drives continuous improvement.
- The inspector viewed the spaces, toys, resources and equipment available for children.

Yetev Lev D'Satmar Nursery registered in 1991 and is situated in Stamford Hill in the London Borough of Hackney. The nursery is open from 9am to 3pm Sunday to Thursday and from 9am to 1pm on Friday throughout the year. Although there are suitably qualified staff ready to transfer from another setting when children attend, there are currently no staff working at the setting as there are no children on roll.
