### Summary of key findings for parents

#### This provision is outstanding

- Children make exceptional progress in their learning because the quality of the teaching is outstanding.
- Children have access to an extensive range of high-quality, motivating and challenging activities and experiences that meet their needs across all the areas of learning.
- Staff enable children to develop extremely secure attachments and make exceptionally strong relationships with all children and adults in the setting. This ensures they settle quickly and develop a strong sense of belonging and security.
- Children are extremely well safeguarded because the staff have a thorough understanding of their responsibilities to protect them. They have an excellent knowledge of local procedures and how to implement them if they have a concern about a child in their care.
- Children's behaviour is excellent. The staff are exceptional role models for the children and they lead by presenting the best example for them to follow.
- Staff build exceedingly strong partnerships with parents and liaise closely with other settings and schools. This ensures extremely effective communication and continuity in children's learning and development.
- Staff supervision is robust and staff observe each other's practice regularly. They offer constructive feedback to each other to ensure children receive the highest standard of care and learning.
- There is an extremely strong drive for self-evaluation and improvement. Staff plan an effective programme of training and professional development to ensure exceptional outcomes for children.

## What the setting needs to do to improve further

#### To further improve the quality of the early years provision the provider should:

 enhance opportunities for children to use a wider range of technology to fully extend their learning.

#### **Inspection activities**

- The inspector observed staff interaction with children, indoors and outdoors.
- The inspector held discussions with staff and children throughout the inspection.
- The inspector carried out a joint observation of an activity with the lead teacher.
- The inspector took account of the views of parents by speaking with them on the day and reading their questionnaire feedback.
- The inspector examined children's progress records, staff planning, self-evaluation, and sampled a range of other documentation, including policies and procedures.

## **Inspection findings**

# How well the early years provision meets the needs of the range of children who attend. This is outstanding

Staff provide an outstanding variety of interesting and motivating experiences that promote children's learning in all areas of the curriculum. Children are free to choose from an extensive variety of resources. Staff assess children's freely chosen play and the activities provided by adults. This ensures that any gaps in children's learning are rapidly closed. Children learn intriguing facts about the world from a very young age. As a result, all children make exceptional progress in their learning. At the inspection, children flocked around a favourite activity with a model volcano. They were fascinated to learn vocabulary, such as 'magma' and 'lava'. Staff extended this learning extremely well by introducing matching cards with associated words. This helped to strengthen the learning and encouraged children's development in literacy and mathematics. Therefore, staff help children to develop the skills they need for school and a motivation to learn.

## The contribution of the early years provision to the well-being of children is outstanding

Children learn exceptional skills of independence. They set up their own activities and tidy them away when completed. They manage their own personal care according to their age and level of ability. Children spend time each day exercising in the fresh air. At the inspection, they thoroughly enjoyed watering plants and making mud puddles in the flower beds. Children are encouraged to look after each other and make friends. They cooperate with each other extremely well and take turns as they balance on wooden blocks. They help each other replace the blocks when they fall down. All areas of learning are available to children, indoors and outdoors. Children read stories to each other and sing songs. They learn about continents and past events to develop their understanding of the world. They use a variety of electronic gadgets to promote learning about technology. However, they have less access to computers which reduces some children's experience of technology.

# The effectiveness of the leadership and management of the early years provision is outstanding

Staff have a complete and thorough knowledge and understanding of the Early Years Foundation Stage. They link the areas of learning exceedingly well with the Montessori approach, and children receive an exceptionally high standard of teaching and learning. Children are safe in the setting because staff carry out exceptionally thorough risk assessments of the premises and outings. Staff are extremely well organised. They keep meticulous records and the setting is exceedingly well managed. Staff are highly qualified and use the expertise gained through their qualifications to promote exceptional outcomes for children. Staff regularly observe children as they play and analyse their progress. They encourage parents to share in their children's learning at home and to engage with the setting. Parents compliment staff on the care their children receive.
