Summary of key findings for parents

This provision is good

- Staff provide a wide range of activities that promote children's learning. Consequently, children are enthusiastic learners who are keen to explore and investigate.
- Staff build warm relationships with children. They know children well and form strong bonds with them. As a result, children demonstrate that they are happy, confident and feel secure in the pre-school.
- Staff make their expectations for children's behaviour very clear. Children behave well and respond positively to the needs of others as they share and take turns.
- Partnerships are a key strength. Staff establish strong and trusting partnerships with parents. They work closely with parents and other professionals to support children's individual care, development and learning needs.

It is not yet outstanding because:

- Not all staff give children time to think about their responses to questions that they are asked.
- Older children do not have sufficient opportunities to extend their learning outdoors.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- give children sufficient time to consider their responses to questions, in order to develop their thinking skills, language and vocabulary
- provide a wider and more challenging range of experiences outside, in order to support the active learning for older children and children who prefer being outdoors.

Inspection activities

- The inspector observed activities in the pre-school and spoke with the staff.
- The inspector and manager undertook a joint observation of a teaching activity.
- The inspector looked at children's assessment records, planning documentation, evidence of the suitability of staff and a range of other documentation, including the safeguarding procedures.
- The inspector took account of the views of parents spoken to on the day.
- The inspector reviewed the provider's self-evaluation form.

Inspection findings

How well the early years provision meets the needs of the range of children who attend. This is good

The pre-school provides a rich and vibrant learning environment, where children happily enjoy a stimulating range of activities. Staff regularly observe children and effectively use these observations to plan individual next steps in their learning. There is a good mix of adult-led and child-initiated play experiences, which encourages children to be active learners as they move freely between activities of their choice. For example, children are keen to select and share a book of their choice from the mobile library. The interactions between staff and children are strong. Staff talk to children and use questions to extend their communication and language skills. However, on occasion less experienced staff pose questions but do not wait for children's response. Children are not fully supported in developing their thinking skills as they consider their reply. Staff skilfully extend children's learning as they introduce simple mathematical concepts, such as shape and size. While constructing a wooden track circuit together, staff encourage children to talk about the colour, shape and size of the train set pieces. As a result, children enhance their early mathematical development and are gaining skills which help prepare them for their next stage in learning.

The contribution of the early years provision to the well-being of children is good

Children receive a warm and friendly welcome to the pre-school. They demonstrate a positive approach to learning, supported by the cheerful interactions of the staff team caring for them. Staff support children's emerging understanding of the importance of a healthy lifestyle that involves physical exercise and a healthy diet. Children benefit from regular fresh air and exercise during outdoor play. They play outside on a daily basis, which promotes children's developing physical skills and confidence. Children choose from a range of physical play equipment, including wheeled toys, hoops and balls. However, there are fewer challenging experiences outdoors to fully support active learning, particularly for older children and those who prefer being outside.

The effectiveness of the leadership and management of the early years provision is good

The provider and staff have a good knowledge and understanding of the safeguarding policies and procedures and are aware of their responsibilities. The manager monitors the educational programmes, ensuring that children's needs are clearly identified and continually met. The manager and staff team demonstrate a commitment to the continual development of the provision and continue to identify priorities for improvement. The manager monitors staff performance, both informally through working alongside the staff and more formally through annual appraisals. Staff are supported to attend relevant courses and gain additional qualifications to improve their knowledge and the quality of the provision for children. The manager uses regular staff meetings to discuss and share any ideas and practice issues to further promote effective outcomes for children.

St Peters Thundersley Preschool registered in 1999. The pre-school employs 10 members of childcare staff, eight of whom hold appropriate early years qualifications at level 3 and above. The pre-school is open five days a week during school term times from 9.15am to 11.45am, with additional sessions on Wednesday and Friday from 12.15pm to 2.45pm.
