Summary of key findings for parents

This provision is good

- Staff observe and assess children's level of achievement, obtain information from parents and plan effectively for individual learning.
- Staff assess and minimise potential risks effectively. They are aware of their responsibilities to protect children from abuse and neglect. Staff-to-child ratios exceed minimum requirements and deployment of staff is good.
- Children's emotional security is addressed well. Staff members' relationships with children are good and children are happy and settled.
- Partnerships with parents are good. Parents share very positive views about the provision. They comment on the friendliness of staff, the welcoming environment, staff members' enthusiasm and how they encourage children's development.
- Staff support children's mathematical learning effectively and children spontaneously use mathematical language while they play.
- Documentation required for the safe and efficient management of the provision and to ensure that the needs of all children are met, is well maintained and implemented.
- Children's independence is promoted well by staff. They learn to manage their self-care needs, decide whether to play with activities in the playroom or outside. They select resources for themselves from low-level storage units.

It is not yet outstanding because:

- Staff do not always give children time to think and put their thoughts into words in response to questions that they are asked.
- Children's learning with regard to awareness of their good health is not always reinforced by staff.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- extend children's thinking and speaking skills, giving them more time to put their thoughts into words when responding to questions
- help children to gain an even better understanding of how good practices with regard to sun safety and eating can contribute to their ongoing good health.

Inspection activities

- The inspector observed activities in the indoor and outdoor play areas.
- The inspector held meetings with the provider/manager, and spoke to staff and children at appropriate times during the inspection.
- The inspector conducted observations of the activities and evaluated the teaching methods with the provider/manager.
- The inspector looked at a selection of children's records, policies and procedures and a range of other documentation.
- The inspector checked evidence of staff members' suitability, qualifications and training.
- The inspector took account of the views of parents.

Inspection findings

How well the early years provision meets the needs of the range of children who attend. This is good

Staff ensure that children develop skills in readiness for school. Children's manipulative skills are good. Staff encourage them to make marks with their fingers and with tools in dough and sand. They choose from a variety of writing materials and pencil control is developing well. Children are learning to use scissors. They cut up their own collage and use glue brushes competently to create pictures. Children use their good language skills while they chat with staff and with their friends. However, staff do not always fully support children's thinking and speaking skills. There are times when they do not give children sufficient time to answer the questions that they ask. Children's mathematical learning is supported well by staff. Each day begins with a group time and children count the number present. They count to 10 and talk about whether this is a little number or a big number. Children say that 10 has two digits.

The contribution of the early years provision to the well-being of children is good

Children's personal, social and emotional development is given a high priority by staff. Their emotional security begins with a settling-in period that is agreed with parents. Children play in a safe and welcoming environment. They behave well. Staff boost children's self-esteem because they praise positive behaviour, such as sharing. Their good health is promoted generally well. Children are physically active everyday and in hot weather staff ensure that parents have applied sun cream. Staff make sure that children wear hats outside and have access to drinking water. However, they do not always clearly explain to children why these precautions are necessary for their good health. Parents provide substantial snacks but staff do not always encourage children to consider eating the more healthy food items before the treats.

The effectiveness of the leadership and management of the early years provision is good

Children's health and safety is addressed well by staff. At the time of the last inspection, actions linked to welfare requirements were raised and these have been addressed well. Changes to the staff team were made following the inspection. Recruitment and selection procedures are clear and vetting procedures for staff are thorough. The provider and staff demonstrate a commitment to reviewing the provision to identify priorities that have a positive impact on children's care and learning. All staff are experienced and hold qualifications at level 3. They have attended training in order to update their knowledge on teaching and planning for learning. The provider is successfully monitoring staff members' practice and identifies the benefit of recent leadership and management training. This has given her greater confidence in discussing with staff the areas that she has identified for improvement. Children are safeguarded because the provider ensures that staff are aware of child protection procedures. Staff work effectively with parents and other early years providers to ensure continuity of care and learning for children.

Pumpkin Patch Preschool was registered in 2014. The pre-school employs four members of childcare staff all of whom hold early years or playwork qualifications at level 3. The pre-school opens during term time only, Monday to Friday from 9am to 12pm. It provides funded early education for three- and four-year-old children.
