Summary of key findings for parents

This provision is outstanding

- The childminder's teaching is outstanding. She skilfully extends children's learning at every opportunity. As a result, children make excellent progress in all areas of their learning and development and are extremely well prepared for starting school.
- The childminder has established extremely warm and caring relationships with the children in her care. Her calm and nurturing manner ensures that each child receives targeted, individual attention, which makes them feel valued and respected.
- The childminder has an excellent understanding of safeguarding and keeping children safe from harm. Robust policies and procedures are in place and the childminder ensures that her knowledge is kept up to date by regularly accessing training. This means children's safety is given the highest priority.
- Partnerships with other settings children attend and other professionals are outstanding. The childminder recognises the importance of working in partnership with others to ensure that children have continuity in their care and learning.
- Parents are highly valued as partners and an effective two-way flow of information means children benefit from an entirely collaborative approach to their care and learning.
- The childminder has robust systems for reflecting on her practice. She actively seeks the contributions of both parents and children to identify priorities for continued improvement.

Inspection findings

How well the early years provision meets the needs of the range of children who attend. This is outstanding

The well-qualified childminder has an outstanding knowledge of how children learn and develop. She skilfully records observations and uses her expert knowledge to plan precisely for children's next steps in learning. The childminder actively supports children's speech and language through her consistent interaction and her skilful questioning. This totally inspires their learning and extends their vocabulary. Therefore, children take part in in-depth conversations that are initiated as they play. Children enjoy looking at photographs displayed in their record books and recall past events. For example, the last time they were riding their balance bicycle. They delight in taking part in numerous art and craft activities of their choosing, such as making pasta bracelets. The childminder is considering introducing more activities for children to explore and investigate. Strong partnerships with parents ensure that information is shared successfully and provide continuity of children's care and learning.

The contribution of the early years provision to the well-being of children is outstanding

Children enjoy a highly positive relationship with the childminder. She is an excellent role model who has a very calm and caring disposition and is very attentive towards all children. She has high expectations of children and builds on their confidence, emotional well-being and self-motivation. As a result, children demonstrate exceptionally high levels of self-control and independence. Children have excellent opportunities to develop their physical skills and social skills. They visit local community groups where they can access larger play equipment and socialise with other adults and children. During these visits, children have the opportunity to meet people who help them, such as fire fighters and the police. These encounters enhance all aspects of children's development, including their understanding of how to keep themselves safe. Children are becoming ready for school. This is because the childminder places the highest priority on ensuring that, from a young age, children develop the necessary skills and coping strategies for their future moves to other settings, including school.

The effectiveness of the leadership and management of the early years provision is outstanding

The childminder has an excellent understanding of the requirements of the Early Years Foundation Stage. She rigorously implements her safeguarding procedures and risk assessments to maintain children's safety at all times. The childminder is totally committed to her role. She demonstrates this through her highly successful, well-documented aspiration to maintain the highest possible levels of practice. She provides an extensive range of resources for children, which meets their needs and interest. The childminder is proactive in continuing her professional development. The impact of the childminder's training is evident in her practice, as she skilfully uses her knowledge and understanding to effectively support children's learning. Her analysis of the progress children make over time, and the excellent partnership working in place, helps to ensure that children's individual needs are exceedingly well met.
