- The childminder has a good range of toys, resources and activities to help promote children's learning.
- The childminder understands the importance of monitoring children's progress and sharing this with parents and other professionals.
- The childminder has a good understanding of safeguarding and child protection procedures. She knows how to report concerns for a child's welfare to keep them safe.
- The childminder understands the importance of teaching children about healthy foods and giving children access to fresh air and exercise.
- The childminder understands the importance of praising children for good behaviour and teaching them about the rules of the setting.
- The childminder keeps up to date with early years developments by doing her own research and talking to other childminders.
- The childminder understands the need to evaluate her practice in order to provide a quality early years setting.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children.
