The provision meets requirements

- The childminder knows how to provide a welcoming environment in which children can settle and gain confidence. She organises the day so that children will be able to play with others and widen their circle of friends.
- The childminder is able to demonstrate a suitable understanding of the learning and development requirements. This means that she is able to support children's learning and plan for their next steps to help them make progress.
- The childminder has an appropriate range of resources to provide children with variety. She demonstrates a sound understanding of the importance of ensuring that the environment and resources will stimulate children and engage their interests.
- The childminder understands how to care for children's physical needs. She knows to teach consistent personal hygiene practice, to talk about healthy snacks and to offer plenty of opportunities to be out in the fresh air.
- The childminder ensures that the premises are safe and secure. She has a sound understanding of her role and responsibilities for safeguarding and child protection.
- The childminder understands the importance of working in partnership with parents and other agencies. She knows to exchange useful information so that there are consistent links to support children's care and well-being.
- The childminder is able to evaluate her practice. She understands how children's and parents' views can be used to inform plans for future improvements.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
