The provision meets requirements

- Staff fully understand how to promote the children's health and well-being. They demonstrate how they intend to provide children with a choice of healthy snacks and drinks, along with daily opportunities for fresh air and exercise.
- Staff have a sound knowledge of how to manage children's behaviour in a positive way and understand the importance of ensuring children are happy at the club. They recognise that this allows them to build good relationships and to get to know individual children well.
- Staff understand the need to work with parents and the host school children attend to share information about children and support their progress.
- Staff are well qualified and have a secure understanding of the requirements of the Early Years Foundation Stage. They demonstrate a good awareness of how to plan a wide range of challenging experiences that will complement the learning children gain at school.
- The management understands the importance of reflecting on the service they provide to help them make continuous improvements. Actions from the last inspection have been addressed. Consequently, staff now understand the safeguarding policy and how to report a concern about a child. As a result, children are kept safe.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector held meetings with the deputy manager of the provision and the head teacher of the host school.
- The inspector looked at children's assessment records and planning documentation.
- The inspector checked evidence of the suitability and qualifications of staff working with children, the manager's self-evaluation form and improvement plan.

Schoolfriend Clubs @ St Wilfrids was registered in 2008. The club employs three members of childcare staff. Of these, two hold appropriate early years qualifications at level 3. One holds a qualification at level 2. The club opens Monday to Friday, term time only. Sessions are from 3.20pm until 5.45pm. The club serves children who attend St Wilfrids Catholic Primary School.
