Summary of key findings for parents

This provision is outstanding

- Children are kept safe because the childminder and her assistant have an excellent understanding of their responsibilities with regard to safeguarding and child protection. They ensure the home setting is continually risk assessed and supporting policies to keep children safe are in place and reviewed regularly.
- The quality of teaching is excellent. The childminder and her assistant are immensely enthusiastic and provide children with rich and varied activities, which challenge them to the optimum level. Consequently, all children, including the two-year-olds, are making excellent progress across all areas of learning.
- Children are highly motivated and their behaviour is exceptional. This is because the childminder and her assistant know the children very well and promote their personal and emotional development to the highest standards.
- Partnerships with other professionals and local nurseries and schools are significantly embedded. All children, including those who have special educational needs and/or disabilities, receive expert support and are well prepared for their future learning.
- The childminder is highly motivated. Self-evaluation is comprehensive and identifies areas for improvement, which are rapidly addressed. This ensures learning experiences for children are significantly enhanced.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

provide more opportunities for children to become deeply involved in storytelling activities.

Inspection activities

- The inspector observed children's play both indoors and outdoors, including adult-led and child-initiated activities.
- The inspector conducted a joint observation with the childminder.
- The inspector asked the childminder questions about her practice at appropriate times throughout the inspection.
- The inspector spoke to the childminder's assistant during the inspection.
- The inspector looked at children's assessment records and the planning documentation.
- The inspector checked evidence of suitability of all household members and the childminder's qualifications. She also looked at the childminder's self-evaluation form and discussed her improvement plan.
- The inspector took account of the written feedback from parents.

Inspection findings

How well the early years provision meets the needs of the range of children who attend. This is outstanding

The childminder has a very strong focus on providing exciting and highly-stimulating learning experiences for children of all ages. Children have excellent opportunities to develop their own ideas and be active learners. Children's readiness for school is substantially enriched through stimulating activities that promote literacy and mathematical development. Interactions between the childminder, her assistant and children are superb. Children are supported to think critically and they actively contribute to tasks. The childminder promotes children's thinking and language and encourages them to explore, have a go and try new things. Precise assessments and the clear identification of children's next steps in their learning help the childminder plan for their future development. Strong relationships with parents and including them in their child's learning provide a consistent approach and help forge a link with their home. Children's learning and development are exceptionally well promoted in both environments. They make rapid progress given their starting points.

The contribution of the early years provision to the well-being of children is outstanding

Children settle well and form extremely good attachments with the childminder and her assistant. Playing and exploring comes naturally to children as they move around the vibrant environment. Children especially enjoy the storytelling sessions. Their love of books is evident. However, the childminder has not considered fully how she might increase children's own involvement in telling stories. Children are expertly supported to understand and implement good hygiene procedures. Healthy snacks and meals are provided. Physical play takes place in the superb outdoor area that is exciting and challenging to all children. Children have a high level of knowledge about living a healthy lifestyle.

The effectiveness of the leadership and management of the early years provision is outstanding

The childminder and her assistant have an excellent understanding of their roles and responsibilities in the delivery of the Early Years Foundation Stage. Meticulous supervision of her assistant and training plans are in place. Since the last inspection, the childminder has focused on improving her practice and raising it to an outstanding level by completing a childcare qualification. She has vastly improved her documentation, observation, assessment and tracking systems to improve the education for all children. Children's progress is precisely tracked, focusing on each areas of learning and taking account of the characteristics of effective learning. The childminder ensures children receive highly skilled intervention if any gaps in learning and development are identified.

She supports a number of children with special educational needs and/or disabilities.
