## **Summary of key findings for parents**

#### The provision does not meet requirements

- The childminder does not have all the appropriate fire controlling equipment available for use for example, fire blanket. This is a breach of the statutory requirements for both the Early Years Register and the associated Childcare Register.
- The childminder has a clear understanding of the learning and development requirements in the Early Years Foundation Stage. She knows how to use observations to plan activities and assessment to enable children to make progress in their learning.
- The childminder has a good understanding about the child protection procedures she will follow should she have concerns about a child in her care.
- The childminder teaches children the benefits of a healthy lifestyles through healthy snacks and meals and by encouraging physical exercise in the park and garden.
- The childminder teaches the children how to keep safe. For example, she explained how she teaches children about the emergency evacuation procedure and how to use equipment safely.
- The childminder understands the importance of working in partnership with parents and other agencies. She discussed the ways she exchanges information about a child's daily activities and progress and through policies and procedures her practice.
- The childminder completes a daily risk assessment to reduce any risks to children and has risk assessments showing how she reduces the risks on outings.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
