The setting does not meet legal requirements for early years settings

### Summary of key findings for parents

#### The provision does not meet requirements

- The provider has failed to notify Ofsted of the changes to the nominated person, committee members and the new manager. This is also a breach to the requirements of the Childcare Register.
- Not all records and documentation to verify staff suitability and qualifications are available for inspection, as required.
- Staff are able to plan a variety of fun activities with the children. They offer a range of resources to capture children's interests, supporting their independence and involvement. This shows they have addressed a recommendation raised at their last inspection.
- Staff have a secure understanding of the Early Years Foundation Stage. Some staff work in the reception class and schools the club serves, meaning they are aware of children's individual needs and can provide support when needed.
- Staff provide a secure environment for children to play in. Staff help children to understand how to keep themselves safe through conducting regular fire evacuations and discussing different emergency scenarios.
- The manager and staff access training, such as first aid and safeguarding, to update their practice.
- Management recognises the importance of improving their provision, and include children and staff's views to identify strengths and areas for further improvement.
- Staff have a secure understanding of safeguarding matters and procedures to follow should they have a concern about a child's welfare.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

## What the setting needs to do to improve further

#### To meet the requirements of the Early Years Foundation Stage the provider must:

ensure that evidence of staff suitability is available for inspection, including qualification certificates and Disclosure and Barring Service checks.

#### To meet the requirements of the Childcare Register the provider must:

- inform Ofsted of the name, date of birth, address and telephone number of any person working with children (compulsory part of the Childcare Register)
- inform Ofsted of the name, date of birth, address and telephone number of any person working with children (voluntary part of the Childcare Register).

#### **Inspection activities**

- The inspector sampled documents, including staff records, policies, children's enrolment details and consents.
- The inspector toured the areas used by the club and viewed resources.
- The inspector held discussions with the manager and staff.

Lady Modifords Out of School Club registered in 1999. A committee, set up by the governing body, manages the club. It operates from Lady Modifords school hall in the village of Walkhampton, Devon. The club operates from 7.30am to 9am and 3.15pm to 6pm, Monday to Friday, during term times. The club employs three members of staff, two of whom are qualified. The manager has a level 5 qualification and one member of staff has a level 3. There were no children in the early years age range on roll at the time of this inspection.
