Summary of key findings for parents

This provision is outstanding

- The childminder is highly skilled at observation, assessment and planning. She captures detailed and comprehensive information about how children learn, by closely observing their play and involvement with others. She uses his expert knowledge of the areas of learning to plan meaningful activities, which are skilfully tailored to children's individual interests and needs.
- The childminder provides excellent learning opportunities, through imaginative and creative activities and projects. This ignites children's enthusiasm for learning.
- The childminder shows a sensitive and caring nature towards children. She gently guides them towards considerate behaviour, by encouraging them to make responsible choices and to think about the feelings of others.
- The childminder's home is exceptionally well organised. She creates stimulating play areas indoors and uses the garden frequently to significantly enhance children's enjoyable and challenging learning experiences. A varied and stimulating range of high-quality toys and equipment are freely accessible to children. This encourages them to actively explore their surroundings.
- The childminder has extensive knowledge of all safeguarding procedures. Consequently, she knows how to protect children from harm and when to notify authorities of any concerns about a child's welfare.
- The childminder attends mandatory training, carries out her own research and exchanges examples of good practice and activities with other childminders. This has an extremely positive impact on children, who benefit from outstanding learning experiences.
- Children make excellent progress because the childminder fosters exceptionally positive relationships with their parents and other practitioners. She works closely with them to skilfully extend their children's skills and understanding.

Inspection findings

How well the early years provision meets the needs of the range of children who attend. This is outstanding

The childminder fully understands, and is very responsive to, each child's characteristics and interests, promptly adapting her teaching and resources to cater for these. As a result, young children are confident, eager to take part and have fun. The childminder provides a broad range of exciting, creative activities to significantly enhance children's mathematical development. For example, children show high levels of interest as they create and decorate their boat made from recyclable boxes. They develop an excellent understanding of size, shape and measure as they recognise big and small containers and cut string to the correct length. The childminder skilfully enhances children's learning by introducing words to describe flat and solid shapes. This helps children to connect mathematical ideas to their play. The childminder is very skilled at playing alongside children and knowing precisely when to intervene to extend children's learning. She uses careful questioning and gives children opportunities to explain and give reasons for why something has happened. Every opportunity is taken to encourage communication and language skills further, and to introduce new vocabulary through discussion and role play. Consequently, children make excellent progress and develop exceptional skills to enhance their future learning, in readiness for school. The childminder regularly discusses and reviews children's progress and learning priorities with parents.

The contribution of the early years provision to the well-being of children is outstanding

The childminder expertly tailors settling-in arrangements for new children. She wants children and their families to have enough time to get to know her, her family and the daily routines and activities. The childminder talks to children with positive encouragement at all times, which helps them to develop their confidence and high levels of self-esteem. Consequently, children thoroughly enjoy their time with the childminder. She helps preschool children to manage their self-care with high levels of independence, by encouraging them to wipe their own nose and wash their hands when needed. Children benefit from nutritious meals, snacks and drinks, which include freshly prepared ingredients. The childminder ensures children play outside regularly, resulting in opportunities for them to develop their skills, such as climbing and running. This helps them to develop a healthy lifestyle and fosters their healthy growth and development.

The effectiveness of the leadership and management of the early years provision is outstanding

The childminder has excellent knowledge of the Early Years Foundation Stage. She is passionate about her work with children and families. The childminder is extremely motivated and uses her skills and knowledge well to ensure she offers a high-quality provision that caters for their individual needs. As part of this, the childminder confidently evaluates the overall effectiveness of her childminding service and how this impacts on children's care, learning and development. She has already identified further training to enhance her teaching knowledge even further to ensure she maintains and continuously builds upon her excellent quality practice.
