Monitoring for provision judged as not met (enforcement)

An Ofsted inspector, Linda Williamson, monitored your provision on 22/06/2015 following your inspection where the provision was judged to be not met (enforcement).

Outcome of monitoring

As a result of our inspection on 19/05/2015, we sent you a welfare requirements notice. If you were set actions at the inspection, or as a result of our subsequent monitoring or investigations, these are included at the end of this letter.

The welfare requirements notice required you to take the following actions: train all staff to understand the safeguarding policy and procedures, and ensure that they have up-to-date knowledge of safeguarding issues to protect children effectively,

implement robust vetting procedures for all adults working with children to determine their suitability, including by obtaining a Disclosure and Barring Service (DBS) check for them,

ensure those staff whose suitability has not been checked do not have unsupervised contact with children,

ensure that there is a named deputy who is capable and qualified to take charge in the manager's absence.

ensure at least one person who has a current paediatric first-aid certificate is on the premises and available at all times.

You were also sent a notice to improve which asked you to take the following actions to meet the requirements of registration on the Early Years Register:

devise and implement effective procedures for staff induction so they understand their roles and responsibilities,

ensure records are easily accessible and available for inspection, including the record





of complaints, and staff suitability checks and qualifications ensure public liability insurance is in place at all times

You were also sent a notice to improve which asked you to take the following actions to meet the requirements of registration on the compulsory and voluntary parts of the General Childcare Register:

ensure that no individual who is unsuitable to work with children has unsupervised access to children

train all staff on the written statement of procedures to be followed to safeguard children from abuse or neglect

implement effective systems to ensure all staff are suitable to work with children which must include obtaining an enhanced DBS check

provide or secure the provision of any training which is necessary to ensure that all staff have suitable skills and experience to care for children

make available to Ofsted, on request, summary of complaints made in relation to the requirements during the past 12 months and the action that was taken as a consequence

produce for Ofsted, on request, a list of such complaints made during the previous three years

inform Ofsted of the appointment of a new manager

ensure insurance in respect of liability which may be incurred for death, injury, public liability, damage or other loss, is in place

ensure at least one person who is caring for children has an appropriate first-aid qualification

We carried out a monitoring visit on 22 June 2015 to assess the progress you had made in addressing the Welfare Requirements notice and the notice of actions set for improvement.

We found that you had met the Welfare Requirements notice because following the inspection you made immediate arrangements for an experienced qualified staff member from your other setting to work at this site. As a result, children are supervised and members of staff are monitored by an adult who has been suitably checked. There is at least one person who has a current paediatric first-aid certificate on the premises and available at all times. You have explained how you will provide paediatric first-aid training for all staff this month. You have reviewed your processes for vetting new staff and ensure you take prompt action to obtain a DBS check for them as soon as possible. The current staff team includes a manager and deputy manager. Staff have received training on the updated safeguarding policy and procedures. Staff are able to demonstrate an improved knowledge and understanding of their roles and responsibilities to safeguard children from abuse or neglect.



During the visit you provided evidence to show there have been no complaints made in relation to the requirements about your provision for over three years. You explained how you will provide additional training for staff members to build upon their skills and experience. You have informed Ofsted of the appointment of a new manager. You have obtained insurance in respect of liability which may be incurred for death, injury, public liability, damage or other loss. You explained how you have improved the induction procedures to ensure staff understand their roles and responsibilities.

Having considered all the evidence, the inspector is of the opinion that you have taken prompt and effective action to address the points for improvement
