## Summary of key findings for parents

#### This provision is outstanding

- Teaching is rooted in the well qualified and extremely experienced childminder's excellent knowledge and understanding of the learning and development requirements. The childminder makes the most of every opportunity to promote children's learning through play and interesting and challenging activities. As a result, children make rapid progress in relation to their starting points.
- The childminder provides children with an excellent range of rich, imaginative and interesting activities, which means that they develop into enthusiastic and motivated learners. Consequently, children of all ages develop a superb range of skills and attitudes that prepare them exceptionally well for future learning and eventually, school.
- Children thrive in this outstanding setting and thoroughly enjoy the time they spend with the childminder. She is highly skilled and sensitive. She helps children to form extremely strong emotional attachments. As a result, children's self-esteem, sense of belonging and feeling of emotional security are promoted to the highest level.
- The childminder teaches children the importance of adopting a healthy lifestyle. Children are provided with an excellent range of nutritional, well-balanced meals and snacks and extensive opportunities for fresh air and exercise. Consequently, children's health and well-being are promoted extremely well.
- Arrangements for self-evaluation are rigorous, sharply focused on teaching and learning and take into account the views of children and parents. This ensures that strengths and weaknesses are effectively identified and addressed and plans for improvement are well targeted and achievable.

### What the setting needs to do to improve further

#### To further improve the quality of the early years provision the provider should:

consolidate highly effective arrangements for continual professional development to ensure that the outstanding practice already achieved is sustained and consistently improved upon.

#### **Inspection activities**

- The inspector observed children's activities in the playroom, kitchen and outdoor environment.
- The inspector held discussions with the childminder and talked to children throughout the inspection.
- The inspector carried out an evaluation of a planned adult-led activity with the childminder.
- The inspector checked evidence of the qualifications of the childminder and suitability of adults living on the premises.
- The inspector discussed the process for self-evaluation with the childminder.
- The inspector looked at various documents, including a sample of policies and procedures, risk assessments, observation, assessment and planning systems and children's individual learning records.
- The inspector took account of the views of parents from written statements obtained by the childminder.

### **Inspection findings**

# How well the early years provision meets the needs of the range of children who attend. This is outstanding

The childminder uses her excellent knowledge of how children learn and her expert teaching skills to provide them with an extensive range of opportunities that cover all areas of learning. She skilfully uses a range of highly effective techniques, which have a significant impact on the progress children make in their communication and language development. Consequently, children are confident and articulate communicators. The childminder accurately observes and assesses children's development, in order to plan sharply focused activities for the next steps in their learning. Regular exchange of information about children's achievements and parents' positive contributions to their assessments ensure that their learning is supported at home. All children, including those with special educational needs and/or disabilities and children who speak English as an additional language, are supported extremely well. This is because the childminder works very closely with parents and external professionals to promote each child's learning needs through a highly effective shared approach.

# The contribution of the early years provision to the well-being of children is outstanding

Children are extremely happy, content and well settled in the childminder's home. This is because the childminder gathers comprehensive information from parents about children's care needs, which promotes their emotional and physical well-being. She uses this information well to support children with the settling-in process and to follow their individual routines. Children develop high levels of independence, as the childminder teaches them to do things for themselves whenever possible. She places high priority on the safety of children. She effectively supports children's growing understanding of how to keep themselves safe and healthy. The childminder provides clear and consistent guidance to promote positive behaviour and older children are excellent role models for the younger children. Consequently, children show exemplary kindness and respect to others as they share, take turns and play together in harmony.

# The effectiveness of the leadership and management of the early years provision is outstanding

The childminder's knowledge of safeguarding is exceptional and central to everything that she does. Regular safeguarding training ensures her knowledge and skills are consistently refreshed and updated. The childminder completes extensive risk assessments and carries out daily checks of all areas and activities accessed by the children. As a result, children are consistently protected from harm and play and learn in a safe environment. She carefully monitors children's progress to ensure all of them reach their full potential. As a result, no child is disadvantaged and the achievement gap is narrowing. The knowledge the childminder gains from an extensive programme of training, together with support and advice from the local authority, are used highly effectively to consistently improve practice within the setting. The childminder recognises that ongoing professional development is crucial to ensure that she continues to provide a high-quality service for all children and their families.

She supports children with special educational needs and/or disabilities and children who speak English as an additional language. The childminder provides funded early education for two- and three-year-old children. She holds an appropriate early years qualification at level 3.
