Summary of key findings for parents

The provision meets requirements

- The childminder has the necessary documentation in place to meet the requirements for the Early Years Foundation Stage. She knows how to identify strengths and areas for improvement. The childminder demonstrates that she is committed to enhancing her provision and the outcomes for children.
- The childminder demonstrates a secure understanding of the learning and development requirements. She understands the requirement to observe and plan activities for children and knows how to provide appropriate challenges to help them to make progress.
- The childminder demonstrates a strong understanding of her role to safeguard children. She completes relevant training and regular risk assessments to maintain a safe learning environment.
- The childminder demonstrates a good understanding of how to promote a healthy lifestyle and children's well-being.
- The childminder is aware of the importance of working in partnership with parents and other professionals who may be involved in a child's development, in order to provide continuity in their care and education.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

- The inspector checked documentation, including training certificates.

The childminder was registered in 1997 and lives in the Cheetham Hill area of Manchester. She operates all year round from 7.30am to 6pm, Monday to Friday, except for bank holidays and family holidays. The childminder provides funded early education for two-, three- and four-year-old children. The childminder has a diploma in childcare at level 3.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the Early Years Foundation Stage.
