Summary of key findings for parents

The provision meets requirements

- The provider has a clear understanding of the importance of working in partnership with parents and others involved in the children's care, to promote continuity.
- The provider understands the importance of providing children with appealing activities based on their individual interests and those that challenge their abilities.
- The provider knows how to make the facilities interesting and welcoming to children. He knows to organise activities and resources so children can make independent choices in what they want to play with.
- The provider knows how to promote children's good health. Activities are organised safely, so children take part in lots of physical activities indoor, outdoors and in the school swimming pool.
- The provider understands the importance of staff acting as good role models to children. He recognises the need to help children feel secure by understanding the camp's values of caring, responsibility, honesty, and to respect and value difference.
- The provider understands the importance of staff having a secure understanding of their role and responsibilities to safeguard and protect children. The provider makes sure all staff complete safeguarding training. This prepares them to identify signs and symptoms that cause concern, and what action to take if they have any worries about a child's welfare.
- The provider recognises the need to continue to develop the camp's provision. Parents and children are involved in this to reflect and evaluate the service on offer.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector observed the indoor and outdoor areas used by the children.
- The inspector held discussions with the provider and staff throughout the inspection.
- The inspector looked at relevant documentation and checked evidence of staff suitability and qualifications.
- The inspector took account of the views of parents and children by viewing questionnaires and the camps self-evaluation.

Camp Glide Limited registered in 2013. It operates from Wray Common School, Reigate, Surrey. The camp opens from 8am to 6pm during school holidays only. There are seven staff working at the camp. Of these, one holds Qualified Teacher's Status and three hold recognised early years qualifications. There were no children present, in the early years age range, at the time of the inspection.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register.
