#### The provision meets requirements

- The leadership team demonstrate a suitable understanding of how to develop children's positive behaviour and their self-confidence. This helps children to feel secure.
- Staff promote healthy lifestyles with the children as they provide them with healthy snacks and drinks. This underpins children's understanding of the importance of healthy activities and eating well.
- The leadership team have suitable strategies to ensure all staff have a secure understanding of their role for safeguarding children. They ensure all staff undertake safeguarding training before working with the children, which enables them to be confident in the procedures to follow in the event of a child protection concern.
- The leadership team have detailed protocols to ensure all staff are suitability monitored, appraised and trained to advance their knowledge, skills and practice.
- The leadership team understands how to promote professional working relationships with the school, parents and other professionals, which positively promotes continuity of care and meet the needs of the children.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The Big Adventure Club (Prior Park) registered in 2010 and operates from Prior Park School in the town of Cricklade, north Wiltshire. The setting operates an after-school club and a holiday play scheme. The after-school club operates daily during the school's term time from 7.30am until 8.30am and from 3.30pm until 6pm. The holiday play scheme operates throughout the school's holidays from 8am to 6pm, with the exception to the whole of August where it is closed. The setting employs two staff, who both hold relevant early years qualifications. There were no children present in the early years age range during the inspection.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register.
