Summary of key findings for parents

The provision meets requirements

- The childminder demonstrates a suitable understanding of safeguarding procedures and knows how to report concerns where necessary. She fully understands her responsibility to protect and promote children's care and welfare. The childminder completes child protection training regularly to ensure her knowledge is current.
- The childminder takes appropriate steps to ensure children play in a safe and suitable environment. The childminder discussed how she helps children to learn about their own safety, for example through teaching them about road safety.
- The childminder demonstrates a sound understanding of the required documentation she should keep to promote children's welfare. These include, keeping a daily register of attendance and accident records.
- The childminder has addressed the recommendations set at the last inspection. She has suitable monitoring and self-evaluation processes so that she knows what improvements she can make.
- The childminder demonstrates how she will work closely with parents and other professionals to promote each child's individual health, care and education.
- The childminder has a secure understanding of the learning and development requirements. She understands the importance establishing children's development from the start and ongoing assessment. The childminder intends to plan activities which follow children's interests so that she is able to provide suitable challenges to help them make good progress in their learning.
- The childminder is proactive in completing training courses so that she is able to keep up to date with current legislation and improve upon her practices.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector carried out the inspection through discussion with the childminder.
- The inspector looked at documentation including certificates, policies and procedures, and adult suitability.
- The inspector discussed the process of self-evaluation, including establishing whether the childminder had addressed previous recommendations from the last inspection.
