Summary of key findings for parents

The provision does not meet requirements

- The childminder does not ensure her assistant holds an up-to-date paediatric first-aid qualification in order to respond effectively during an emergency both in the home or when taking children on outings.
- The childminder does not keep an up-to-date daily record of the children being cared for and their hours of attendance. Therefore, she is unable to ensure children's safety fully, in particularly during an emergency. This breach also relates to the requirements of the Childcare Register.
- The childminder does not record or keep full information for each child in her care. Therefore, she is unable to contact relevant people immediately to meet children's safety and well-being needs. This breach also relates to the associated requirements of the Childcare Register.
- The childminder has a sound understanding of how to meet children's developmental needs and to help them progress towards the early learning goals.
- The childminder explains how she would take all reasonable steps to ensure that children in her care are not exposed to risks. She shows a sound understanding of the procedures to follow if she was worried about a child.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What the setting needs to do to improve further

We will issue a welfare requirements notice that requires the provider to:

ensure any assistant who might be in sole charge of children for any period of time holds a current paediatric first-aid certificate.

To meet the requirements of the Early Years Foundation Stage the provider must:

- ensure records have full information for each child being cared for including: full name; date of birth; name and address of every parent and/or carer who is known to the provider; which parent and/or carer the child normally lives with and emergency contact details for parents and/or carers
- ensure a daily record of the names of the children being cared for on the premises and their hours of attendance is kept.

To meet the requirements of the Childcare Register the provider must:

- keep the following records and retain them for a period of two year for each child looked after on the premises including: the name, home address and date of birth of each child; the name, home address and telephone number of a parent/guardian/carer of each child; a daily record of the names of the children and their hours of attendance (compulsory part of the Childcare Register).

Inspection activities

- The inspection carried out as a result of a risk assessment process following concerns received by Ofsted.
- The inspector looked at documents provided by the childminder, including the childminder's training certificates, policies and children's accident records.
- The inspector discussed with the childminder her understanding of how she intends to meet children's learning and care needs effectively.
- The inspector viewed the premises and checked the play resources available to ensure they are safe and secure for children.
