- The childminder has strong relationships with all of the children. They explore their environment knowing that she is close by to support if necessary.
- The children are encouraged to be independent and make choices during their play.
- Partnership working with parents and carers is strong. They feel supported by the childminder and use her as a source of advice when dealing with new or challenging situations regarding their children.
- The childminder adapts her approach and uses a range of teaching methods to promote learning. Children are taught as individuals depending on their ages and stages of learning.
- The childminder is proactive in keeping up to date with changes to legislation; she regularly goes on training to develop her knowledge. This has a positive impact on the service that she is able to provide to children and their families.
- The childminder accurately tracks the progress children make and identifies and plans for the next steps in their learning.

#### It is not yet outstanding because:

On occasion, the childminder uses words that promote incorrect language and do not support the children in learning and using new words correctly.

### What the setting needs to do to improve further

#### To further improve the quality of the early years provision the provider should:

ensure that correct language is being modelled at all times so that children are given the right words and learn how to use them appropriately.

#### **Inspection activities**

- The inspector observed the quality of teaching and learning, both indoors and outside.
- The inspector spoke to the childminder and children at appropriate times throughout the day.
- The inspector took the views of parents into account.
- The inspector looked at documentation, including children's records, planning and assessment, staff suitability and a selection of policies and procedures, such as safeguarding and the complaints procedure.
- The inspector carried out a joint evaluation of teaching with the childminder.

### **Inspection findings**

# How well the early years provision meets the needs of the range of children who attend. This is good

Children have access to a wide range of resources that supports learning across the seven areas. This includes resources that promote an understanding of cultural differences and diversity within the community. Children learn about occupations and develop their imaginations during free-play opportunities. The childminder effectively gathers information about the children when they start at the setting. Clear and good progression can be seen from these initial assessments for all of the children. The childminder shares her assessments with parents and carers and gives them ideas about how they can support learning at home. The childminder supports language development and uses a wide range of strategies with the children. However, on occasion, the childminder uses words, such as 'handies', which do not promote correct language. Children are engaged during adult-led play and spend extended periods of time at these activities given their ages.

# The contribution of the early years provision to the well-being of children is good

Children are encouraged to develop their physical skills and are reminded about the importance of being active. The childminder provides the children with fresh drinking water that is accessible at all times. They have healthy snacks and nutritious meals that allow them to make choices and learn about healthy eating. Children are reminded to wash their hands at appropriate times during the day. Children clearly enjoy being with the childminder and regularly seek her out to be involved in their play. When children start at a new setting or go to school, the childminder supports them to be emotionally ready for this change. The childminder has good strategies for dealing with unwanted behaviour. She has high expectations and, for the most part, the children adhere to these. Issues with behaviour are discussed with parents so that the approach is consistent between home and the childminder's care.

# The effectiveness of the leadership and management of the early years provision is good

The childminder has a good understanding of how to keep children safe and what action to take if she has any concerns regarding a child. The childminder has attended relevant training, which has had a positive impact on the service she provides. The childminder understands the Early Years Foundation Stage and has a good knowledge of the framework. It is used effectively to plan next steps in each child's learning. Self-evaluation is completed regularly and is used to identify areas of the environment or practice that she would like to improve. This is done in conjunction with other professionals, such as the advisory team from the local council. Children are encouraged to take reasonable risks in their play, whilst supervised by the childminder. Risk assessments of the indoor and outdoor environment identify solutions to potential hazards.
