Summary of key findings for parents

The provision meets requirements

- Management has a good understanding of the importance of working in partnership with parents to gather and exchange information about their children's care and learning.
- Management understands the importance of providing children with interesting and challenging activities that build on their confidence and independence. They know to make the facilities interesting and inviting for all children.
- Management understands the importance of teaching children about healthy lifestyles. Guidance is provided to parents on the contents of healthy lunch box options. Activities are organised so children take part in physical activities indoors and outdoors and learn about the importance of excercise.
- Management has a clear understanding of how to keep children safe and to be aware of their own safety. For example, through the completion of risk assessments to identify any potential hazards they need to address to enable children to play safely.
- Through documentation and discussion, management demonstrates a good understanding of the safeguarding and welfare requirements of the Early Years Foundation Stage. Management uses recruitment systems, induction training and staff supervision so staff are clear about their responsibilities.
- Management makes sure staff complete child protection training to safeguard and protect children. They make sure all staff are able to identify and know what action to take should they have any concerns about a child's welfare.
- Management recognises the need to continually monitor and evaluate the club's provision. They involve parents, children and staff in this process to bring about improvement.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector viewed the indoor and outdoor areas used by the children.
- The inspector held discussions with the management team.
- The inspector looked at relevant documentation and checked evidence of staff ongoing suitability and qualifications.
- The inspector took account of the parents' views by viewing questionnaires.

Y-Kids play scheme is operated by YMCA East Surrey and registered in 2007. It operates from a children's centre in Banstead, Surrey. The club opens from 10am to 6pm during school holidays only. There are five staff working at the club, the manager holds a degree in early years and three staff hold recognised early years qualifications. There were no children on roll in the early years age range at the time of the inspection.
