Summary of key findings for parents

The provision meets requirements

- The childminder has a secure understanding of the requirements of the Early Years Foundation Stage. She has a good understanding of how to observe and assess children's development from their starting points, and to plan learning experiences to meet their individual needs.
- The childminder understands how to promote children's health and well-being. She understands the need to provide a healthy diet, fresh air and physical exercise.
- The childminder has a sound understanding of her role and responsibilities to safeguard the children's welfare. She keeps the premises safe and understands the procedures to follow should she have a safeguarding concern.
- The childminder keeps up to date with training, including paediatric first aid, safeguarding and food hygiene. She ensures her public liability insurance remains up to date.
- The childminder has a clear understanding of the importance of working in partnership with parents and others involved in the children's care. She knows how to promote continuity in children's development and learning.
- The childminder knows how to evaluate her practice to make ongoing improvements for the benefit of the children. She has a strong commitment to continuous professional development to enhance her knowledge and skills.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector discussed how the childminder intends to plan and assess children's development and work in partnership with parents.
- The inspector looked at a range of documentation, including qualifications and training certificates, parents' feedback, policies and procedures.
- The inspector checked the suitability of the childminder and other household members.
- The inspector toured the areas of the premises used for childminding and viewed the available resources and toys.
- The inspector discussed the childminder's self-evaluation and improvement plans.

The childminder was registered in 2003. She lives in Ilford in the London Borough of Redbridge. The childminder operates from Monday to Friday, from 8am until 6pm, all year round, except for bank holidays and family holidays. There were no children on roll at the time of inspection.
