The provision meets requirements

- The manager knows the importance of working in partnership with parents and others involved in the children's care to promote continuity.
- The manager understands the importance of providing children with activities based on their individual interest and those that challenge their abilities and build on their confidence.
- The manager recognises the need to continuously evaluate the service. She involves parents, children and staff in this process to bring about change.
- The manager knows how to make the facilities interesting and welcoming to children. She knows to organise activities and outings to enable all children of various abilities to fully participate.
- The manager understands how to promote children's good health and well-being. Activities are organised safely, so all children take part in lots of physical activities in outdoor play and at a local swimming pool.
- The manager uses good recruitment procedures, induction training, staff supervision and briefing sessions so that staff are clear about their responsibilities.
- The manager understands the importance of staff having a secure understanding of child protection procedures. She ensures all staff attend safeguarding training so they are able to recognise and identify what action to take should they have any concerns about a child's well-being.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector observed the indoor and outdoor areas used by the children.
- The inspector held discussions with the manager and staff.
- The inspector looked at relevant documentation and checked evidence of staff suitability and qualifications.
- The inspector took account of the views of parents' spoken to on the day of inspection and sampled a range of parental questionnaires.

There are six staff working directly with the children and additional staff as and when required. All staff hold recognised qualifications at level 3.
