The provision meets requirements

- The provider understands how to safeguard children. The recruitment procedure is robust, regular evacuation drills take place and risk assessment contribute to keeping children safe.
- Effective partnership with parents, professionals and external agencies help secure timely intervention for children who need them. Staff share good practice, via local network groups, to support children.
- The provider demonstrates a strong knowledge and understanding the Early Years Foundation Stage framework and knows how children learn.
- Leaders constantly strive to improve the quality of care children receive. They use feedback and information from parents, children, staff and external agencies to improve practice.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Brightstart Childcare and Education registered in 2006. It is located in the London Borough of Brent. The nursery opens five days a week from 8.30am until 5pm for all year round. The nursery receives funding to provide free early education for children aged two, three and four years. There are seven members of staff who work with children. Of these, one holds Qualified Teacher Status and five hold relevant qualifications from level 3 to level 5. There were no children in the early years age range present during this inspection.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register.
