Summary of key findings for parents

The provision meets requirements

- The provider understands the Early Years Foundation Stage requirements. She knows how to promote children's care and their interests. She ensures staff provide children with a safe and secure environment to promote their well-being.
- The provider ensures staff undertake safeguarding training before each playscheme begins. This means staff know how to identify any concerns and report these to the relevant agencies to promote children's welfare.
- The provider supports staff effectively to develop their professional practice. All staff complete a range of relevant training programmes each year. The provider has met previous recommendations, which drives improvement and benefits children.
- The provider monitors children's progress and staff performance, to ensure they meet children's individual needs well.
- Staff establish good working relationships with parents. They obtain all relevant information from the parents and share children's daily progress with them.
- The provider effectively promotes diversity, so that any children attending can learn about different cultures and backgrounds, through interesting topics about the wider world.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector discussed with the provider her knowledge of the Early years Foundation Stage requirements.
- The inspector viewed the areas of the provision used for the children.
- The inspector viewed some of the provider's documentation, including training certificates and a selection of records and policies.

Redbridge Jewish Youth & Community Care After School Club opened in 1994. It is situated in Ilford, in the London Borough of Redbridge. The playscheme operates during summer holidays, as well as during the October, February and May half terms, from 10am to 4.30pm, Monday to Friday. The breakfast club operates from 8.30am to 10am and the tea-time club from 4.30pm to 6pm. On Fridays, the playscheme finishes at 3pm. There are 57 members of staff, all of whom hold early years qualifications at level 1 or above. There were no children on roll at the time of this inspection.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the Early Years Foundation Stage.
