Summary of key findings for parents

The provision meets requirements

- The manager has an excellent understanding of the learning and development requirements. Staff use their observations and children's interests to plan next steps. As a result, children make very good progress in their learning.
- The manager understands the importance of maintaining effective partnerships with parents to involve them fully in their children's development.
- Links with outside agencies and other professionals are established. Consequently, children receive the necessary support to meet their individual needs, which helps to prepare them for the move to school.
- The manager ensures staff continually update their training and use their knowledge and the self-evaluation process to improve practice for children.
- The manager understands the welfare requirements and reflects this through her policies and procedures. She has a strong understanding of how to protect children from harm and attends frequent safeguarding training.
- The manager is committed to ensuring children benefit from a heathy lifestyle through daily physical activities and through nutritious snacks.
- Staff implement an effective key-person system to help children form secure attachments.
- The manager is highly enthusiastic and passionate. Her drive for improvement is strong and she continually finds ways to enhance the provision to benefit the children.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

- The inspector viewed a range of policies and documentation, including children's records and assessments.
- The inspector checked staff qualifications and their suitability to work with children.

Get Up and Go Community Nursery registered in 1997. It operates from within a community resource building, which is located in the inner city area of Ford in Plymouth. The nursery opens each weekday from 9am to 4pm all year round. The nursery employs eight staff of whom seven hold relevant early years qualifications at level 3 and above. The nursery receives funding for the provision of free early years education for children aged two, three and four years. There were no children present at the time of the inspection.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the Early Years Foundation Stage.
