Summary of key findings for parents

The provision meets requirements

- The childminder understands the importance of safeguarding children. She understands how to use risk assessments to identify and minimise hazards to children.
- The childminder knows how to provide a range of furniture, equipment and toys that are developmentally appropriate for children of different ages and needs.
- The childminder knows how to keep and maintain relevant records that are required for the safe management of the provision and to help meet children's needs. She knows that these must be readily accessible for inspection.
- The childminder understands the indicators that would give for cause concern. She understands the need to help protect children from harm and knows how to proceed if she has any concerns about a child's welfare.
- The childminder knows the need to implement good hygiene practices to reduce the spread of germs and infection to children. She knows how to provide nutritious foods and how to promote healthy lifestyles for children.
- The childminder understands the importance of working in partnership with parents, other providers and external agencies to help her meet children's individual needs.
- The childminder understands how to use assessments to help plan for individual children's learning and development. She knows how to provide activities to help children progress in all areas of learning and of the need to help prepare them for school.
- The childminder knows how to promote children's personal development, including their good behaviour. She understands how to help children learn about respecting each other as they build relationships.
- The childminder has completed a number of training courses to update her knowledge and understands the need to identify how to improve her practice.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector had discussions with the childminder about her role.
- The inspector had a tour of the premises available for childminding with the childminder.
- The inspector viewed the childminder's furniture, toys and equipment available for children's use.
- The inspector looked at the childminder's training certificates and a range of other documents, including the public liability insurance.
