### Summary of key findings for parents

#### The provision meets requirements

- The management team have a secure understanding of child protection and the procedures to follow to safeguard children's welfare. Regular training is undertaken to ensure they keep their knowledge current.
- Management describe clear arrangements for developing effective relationships with parents to share information. Staff understand the importance of obtaining the details they need to meet children's needs and keeping parents well informed about their child's care.
- The management team demonstrate how they promote children's health. This is with regard to how to help children learn about leading a healthy lifestyle through regular exercise, fresh air and a healthy diet.
- The qualified and experienced team demonstrate how they plan a varied and exciting programme of activities. They understand the importance of taking account of children's interests and individual needs to ensure an inclusive service is offered to all.
- The management team demonstrate a good understanding of establishing partnerships with other providers. They explain how they regularly share information to support children's learning and development and general well-being.
- The management team has a good knowledge of how to evaluate the quality of the service they provide. They demonstrate ways of involving parents and children in their evaluations and how they strive for continuous improvement.
- The management team have procedures in place to check the ongoing suitability of staff and monitor their performance through regular supervisions.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

#### **Inspection activities**

- The inspector viewed the areas of the school premises where childcare is provided.
- The inspector discussed with the management team their knowledge and understanding of the Early Years Foundation Stage requirements.
- The inspector viewed a sample of documentation, which included safeguarding and the policies and procedures. She also checked evidence of staff suitability and qualifications.
- The inspector viewed the setting's self-evaluation form and took account of the views of parents and children from recent surveys.

Stay 'n' Play registered in 2012. It is privately owned. The club is open Monday to Friday from 7.30am to 8.50am and from 3.30pm to 6pm during term time, and from 8am to 6pm during school holidays. There are three members of staff, all of whom hold childcare qualifications at level 2 or level 3.
